4	SECTION 1. Chapter 823, Health and Safety Code, is amended

6	Sec. 823.008. ENFORCEMENT BY COUNTY. (a) A county may
7	enforce this chapter.
8	(b) This section does not authorize a county to establish
9	standards for operating an animal shelter.
10	(c) A county may not enforce this chapter at an animal
11	shelter operated by a municipality.
12	Sec. 823.009. CIVIL PENALTY. (a) A person may not cause,
13	suffer, allow, or permit a violation of this chapter or a rule
14	adopted under this chapter.
15	(b) A person who violates this chapter or a rule adopted
16	under this chapter shall be assessed a civil penalty. A civil
17	penalty under this chapter may not be less than \$100 or more than
18	\$500 for each violation and for each day of a continuing violation.
19	This subsection does not apply at an animal shelter operated by a
20	municipality.
21	(c) If it appears that a person has violated, is violating,
22	or is threatening to violate this chapter or a rule adopted under
23	this chapter, the county or municipality in which the violation

1	(1) injunctive relief to restrain the person from

3	(2) the assessment and recovery of the civil penalty;
4	<u>or</u>
5	(3) both injunctive relief and the civil penalty.
6	(d) A bond is not required in an action brought under this
7	section.
8	SECTION 2. The change in law made by this Act applies only
9	to conduct that occurs on or after the effective date of this Act.

10 Conduct that occurs before the effective date of this Act is 11 governed by the law in effect at the time the conduct occurred, and 12 the former law is continued in effect for that purpose.

13 SECTION 3. This Act takes effect immediately if it receives 14 a vote of two-thirds of all the members elected to each house, as 15 provided by Section 39, Article III, Texas Constitution. If this 16 Act does not receive the vote necessary for immediate effect, this 17 Act takes effect September 1, 2009.
