5 SECTION 2. Chapter 325, Government Code, is amended by 6 adding Section 325.0075 to read as follows:

Sec. 325.0075. FINANCIAL AUDIT. The state auditor shall conduct a financial audit under Section 321.0131 of each state agency scheduled to be abolished on a date certain if not continued in accordance with this chapter. The state auditor shall conduct the audit at a time so that the completed audit may be sent to the commission on September 1 of the odd-numbered year before the year the agency is scheduled to be abolished.

14 SECTION 3. The changes in law made by this Act apply in 15 relation to the review by the Sunset Advisory Commission of 16 agencies scheduled to be abolished on or after September 1, 2013, if 17 not continued in accordance with Chapter 325, Government Code, and 18 in relation to any other agencies that by law are reviewed during 19 those review periods by the Sunset Advisory Commission.

20 SECTION 4. This Act takes effect September 1, 2009.
