## A BILL TO BE ENTITLED

## AN ACT

2 relating to the powers and duties of the Castro County Hospital 3 District.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 1013.052, Special District Local Laws 6 Code, as effective April 1, 2009, is amended to read as follows:

Sec. 1013.052. NOTICE OF ELECTION. <u>Notice</u> [Not earlier
than the 30th day or later than the 10th day before the date] of an
election of directors [, notice of the election] shall be published
[one time] in a newspaper of general circulation in Castro County <u>in</u>
accordance with Section 4.003, Election Code.

SECTION 2. Section 1013.062, Special District Local Laws Code, as effective April 1, 2009, is amended to read as follows:

14 Sec. 1013.062. RECRUITMENT OF MEDICAL STAFF AND 15 EMPLOYEES. (a) The board may spend district money, enter into 16 agreements, and take other necessary action to recruit physicians 17 and other persons to serve as medical staff members or district 18 employees, including:

1 education courses at an institution of higher education; and 2 (B) contractually agrees to become a district 3 employee or medical staff member; and 4 (4) providing on a rent-free basis or subsidizing the 5 cost of office space or other facilities for a health care professional, including a physician. 6 7 (b) The board may employ physicians or other health care providers as the board considers necessary for the efficient 8 operation of the district. 9 10 (c) This section may not be construed as authorizing the board to supervise or control the practice of medicine, as 11 12 prohibited by Subtitle B, Title 3, Occupations Code. SECTION 3. Subchapter E, Chapter 1013, Special District 13 Local Laws Code, as effective April 1, 2009, is amended by adding 14 Sections 1013.209 and 1013.210 to read as follows: 15 Sec. 1013.209. ADDITIONAL MEANS OF SECURING REPAYMENT OF 16 17 BONDS. In addition to the authority to issue general obligation bonds and revenue bonds under this subchapter, the board may 18 19 provide for the security and payment of district bonds from a pledge of a combination of ad valorem taxes as authorized by Section 20 1013.202 and revenue and other sources authorized by Section 21 22 1013.206. Sec. 1013.210. USE OF BOND PROCEEDS. The district may use 23 24 the proceeds of bonds issued under this subchapter to pay: 25 (1) any expense the board determines is reasonable and 26 necessary to insure, sell, and deliver the bonds; 27 (2) interest payments on the bonds during a period of

2	through the bonds, not to exceed five years;
3	(3) costs related to the operation and maintenance of
4	a project or facility to be provided through the bonds:
5	(A) during an estimated period of acquisition or
6	construction, not to exceed five years; and

8	acquired or constructed;
9	(4) costs related to the financing of the bond funds,
10	including debt service reserve and contingency funds;
11	(5) costs related to the bond issuance;
12	(6) costs related to the acquisition of land or
13	interests in land for a project or facility to be provided through
14	the bonds; and
15	(7) costs of construction of a project or facility to
16	be provided through the bonds, including the payment of related
17	professional services and expenses.
18	SECTION 4. This Act takes effect immediately if it receives
19	a vote of two-thirds of all the members elected to each house, as
20	provided by Section 39, Article III, Texas Constitution. If this
21	Act does not receive the vote necessary for immediate effect, this

22 Act takes effect September 1, 2009.
