3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Section 502.001, Transportation Code, is amended
5	by adding Subdivision (6-a) to read as follows:
6	(6-a) "Fleet" means a group of at least 25
7	nonapportioned motor vehicles owned by a corporation, limited or
8	general partnership, limited liability company, or other business
9	entity and used for the business purposes of that entity or its
10	affiliates.
11	SECTION 2. Subchapter A, Chapter 502, Transportation Code,
12	is amended by adding Section 502.0023 to read as follows:
13	Sec. 502.0023. EXTENDED REGISTRATION OF FLEET MOTOR
14	VEHICLES. (a) Notwithstanding Section 502.158(c), the department
15	shall develop and implement a system of registration to allow an
16	owner of a fleet to register the motor vehicles in the fleet for an
17	extended registration period of not less than one year or more than
18	eight years. The owner may select the number of years for
19	registration under this section within that range and register the
20	fleet for that period. Payment for the entire registration period
21	selected is due at the time of registration.
22	(b) A system of extended registration under this section
23	must allow the owner of a fleet to register:
24	(1) an entire fleet in the county of the owner's

1	residence or principal place of business; or
2	(2) the motor vehicles in a fleet that are operated

4	(c) In addition to the registration fees prescribed by
5	Subchapter D, an owner registering a fleet under this section shall
6	pay an annual fleet registration fee of \$10 per motor vehicle.
7	(d) A license plate issued under this section may include
8	the name or logo of the business entity that owns the vehicle.
9	(d-1) In addition to all other applicable registration
10	fees, an owner registering a commercial fleet under this section
11	shall pay a one-time license plate manufacturing fee of \$8 for each
12	plate issued that includes on the legend the name or logo of the
