5	SECTION 1. Chapter 54, Government Code, is amended by
6	adding Subchapter II to read as follows:
7	SUBCHAPTER II. ASSOCIATE JUDGES IN BRAZORIA COUNTY
8	Sec. 54.1901. APPLICATION. This subchapter applies to a
9	district court in Brazoria County.
10	Sec. 54.1902. APPOINTMENT. The judge of a district court
11	subject to this subchapter may appoint one or more associate judges
12	to perform the duties authorized by this subchapter, Subchapter GG,
13	and Chapter 201, Family Code.
14	Sec. 54.1903. POWERS. An associate judge appointed under
15	this chapter has the powers provided by this subchapter, Subchapter
16	GG, and Chapter 201, Family Code.
17	Sec. 54.1904. PROCEEDINGS THAT MAY BE REFERRED. (a) A judge
18	of a court may refer to an associate judge:
19	(1) any civil case authorized under Section 201.005,
20	<pre>Family Code;</pre>
21	(2) any criminal case for proceedings involving:
22	(A) a negotiated plea of guilty before the court;
23	(B) a bond forfeiture;

## 1 (D) a postconviction writ of habeas corpus; 2 (E) an examining trial; and 3 (F) any other matter the judge considers 4 necessary and proper; and 5 (3) any drug court proceeding authorized under 6 Subchapter GG. 7 (b) An associate judge may not preside over a criminal trial on the merits, whethe<u>r or not the trial is before a jury.</u> 8 9 SECTION 2. Article 2.09, Code of Criminal Procedure, is amended to read as follows: 10 Art. 2.09. WHO ARE MAGISTRATES. Each of the following 11

12 officers is a magistrate within the meaning of this Code: The justices of the Supreme Court, the judges of the Court of Criminal 13 14 Appeals, the justices of the Courts of Appeals, the judges of the 15 District Court, the magistrates appointed by the judges of the district courts of Bexar County, Dallas County, or Tarrant County 16 17 that give preference to criminal cases, the criminal law hearing officers for Harris County appointed under Subchapter L, Chapter 18 19 54, Government Code, the criminal law hearing officers for Cameron County appointed under Subchapter BB, Chapter 54, Government Code, 20 the magistrates appointed by the judges of the district courts of 21 Lubbock County, Nolan County, or Webb County, the magistrates 22 23 appointed by the judges of the criminal district courts of Dallas 24 County or Tarrant County, the masters appointed by the judges of the district courts and the county courts at law that give preference to 25 26 criminal cases in Jefferson County, the magistrates appointed by the judges of the district courts and the statutory county courts of 27

1 Brazos County, Nueces County, or Williamson County, the magistrates appointed by the judges of the district courts and statutory county 2 3 courts that give preference to criminal cases in Travis County, the county judges, the judges of the county courts at law, judges of the 4 5 county criminal courts, the judges of statutory probate courts, the associate judges appointed by the judges of the statutory probate 6 7 courts under Subchapter G, Chapter 54, Government Code, the 8 associate judges appointed by the judge of a district court under Subchapter II, Chapter 54, Government Code, the justices of the 9 10 peace, and the mayors and recorders and the judges of the municipal courts of incorporated cities or towns. 11

12 SECTION 3. This Act takes effect immediately if it receives 13 a vote of two-thirds of all the members elected to each house, as 14 provided by Section 39, Article III, Texas Constitution. If this 15 Act does not receive the vote necessary for immediate effect, this 16 Act takes effect September 1, 2009.
