1 (2) the covenant must provide for a buy out of the 2 covenant by the physician at a reasonable price or, at the option of 3 either party, as determined by a mutually agreed upon arbitrator 4 or, in the case of an inability to agree, an arbitrator of the court 5 whose decision shall be binding on the parties; and

6 (3) the covenant must provide that the physician will 7 not be prohibited from providing continuing care and treatment to a 8 specific patient or patients during the course of an acute illness 9 even after the contract or employment has been terminated.

10 (c) Subsection (b) does not apply to a physician's business 11 ownership interest in a licensed hospital or licensed ambulatory 12 surgical center.

13 SECTION 2. This Act applies only to a covenant entered into 14 on or after the effective date of this Act. A covenant entered into 15 before the effective date of this Act is governed by the law in 16 effect at the time the covenant was entered into, and that law is 17 continued in effect for that purpose.
