A BILL TO BE ENTITLED

AN ACT

2 relating to identification of certain persons employed to assist a
3 registered lobbyist.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 305.005, Government Code, is amended by
6 amending Subsection (f) and adding Subsection (l) to read as
7 follows:

8 (f) The registration must be written and verified and must
9 contain:

10 (1) the registrant's full name and address;

11 (2) the registrant's normal business, business phone
12 number, and business address;

13 (3) the full name and address of each person:

14 (A) who reimburses, retains, or employs the
15 registrant to communicate directly with a member of the legislative
16 or executive branch to influence legislation or administrative
17 action; and

18 (B) on whose behalf the registrant has
19 communicated directly with a member of the legislative or executive
20 branch to influence legislation or administrative action;

21 (4) the subject matter of the legislation or of the
22 administrative action that is the subject of the registrant's
23 direct communication with a member of the legislative or executive
24 branch and, if applicable, the docket number or other

1 administrative designation of the administrative action;

2 (5) for each person employed or retained by the
3 registrant or by the person described by Subdivision (3) for the
4 purpose of assisting the registrant in direct communication with a
5 member of the legislative or executive branch to influence
6 legislation or administrative action:

7 (A) the full name, business address, and
8 occupation of the person; and

9 (B) the subject matter of the legislation or of
10 the administrative action to which the person's activities
11 reportable under this section were related and, if applicable, the
12 docket number or other administrative designation of the
13 administrative action; and

14 (6) the amount of compensation or reimbursement paid
15 by each person who reimburses, retains, or employs the registrant
16 for the purpose of communicating directly with a member of the
17 legislative or executive branch or on whose behalf the registrant
18 communicates directly with a member of the legislative or executive
19 branch.

20 (1) A registrant is not required under Subsection (f)(5) to
21 include in a registration information concerning another person if:

22 (1) the person assisting the registrant is also a
23 registrant; and

24 (2) any client required to be included in the
25 registrant's registration under Subsection (f)(3) is included in
26 the registration of the person assisting the registrant.

27 SECTION 2. Subchapter A, Chapter 305, Government Code, is

1 amended by adding Section 305.012 to read as follows:

2 Sec. 305.012. SEARCHABLE DATABASE. The commission shall
3 maintain and make available through the Internet a searchable
4 database that includes for each registrant the name of each person
5 employed or retained to assist the registrant as described by
6 Section 305.005(f)(5).

7 SECTION 3. Section 305.005, Government Code, as amended by
8 this Act, applies only to a registration or registration renewal
9 required to be filed under Chapter 305, Government Code, on or after
10 September 1, 2009. A registration or registration renewal required
11 to be filed under Chapter 305, Government Code, before September 1,
12 2009, is governed by the law as it existed immediately before
13 September 1, 2009, and that law is continued in effect for that
14 purpose.

15 SECTION 4. The Texas Ethics Commission shall establish the
16 searchable database required by Section 305.012, Government Code,
17 as added by this Act, not later than January 1, 2010.

18 SECTION 5. This Act takes effect September 1, 2009.
