## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to establishing the Texas Derby.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. The Texas Racing Act (Article 179e, Vernon's
- 5 Texas Civil Statutes) is amended by adding Article 9A to read as
- 6 follows:
- 7 ARTICLE 9A. TEXAS DERBY
- 8 Sec. 9A.001. TEXAS DERBY. (a) The commission shall
- 9 establish the Texas Derby as an annual grade 1 stakes race of
- 10 Texas-bred thoroughbred and quarter horses in this state.
- 11 (b) The commission shall set the date of and the location
- 12 for the Texas Derby. The Texas Derby must be held annually at one of
- 13 the class 1 racetracks in this state on a rotating basis as
- 14 determined by the commission.
- 15 (c) The date of the initial Texas Derby may not be earlier
- 16 than January 1, 2013. Not later than January 1, 2013, the
- 17 commission shall establish the annual rotation for the location of
- 18 the Texas Derby by conducting a blind drawing of the names of each
- 19 class 1 racetrack in this state. This subsection expires
- 20 <u>January 1, 2014.</u>
- Sec. 9A.002. QUALIFYING RACES. (a) The commission shall
- 22 establish two annual races of Texas-bred thoroughbred and quarter
- 23 horses to qualify horses for entry into the Texas Derby.
- 24 (b) The commission shall establish for each qualifying

- 1 race:
- 2 (1) the date on which each race will be conducted,
- 3 provided the date is not the same for each race; and
- 4 (2) the class 1 racetrack where each qualifying race
- 5 will be conducted, provided that each race is conducted at a
- 6 different racetrack in a county with a population of at least two
- 7 million or adjacent to a county with a population of at least two
- 8 million.
- 9 (b-1) The date of a qualifying race for the initial Texas
- 10 Derby may not be earlier than January 1, 2012. This subsection
- 11 expires January 1, 2013.
- 12 (c) A horse is not eligible to run in a qualifying race or
- 13 the Texas <u>Derby unless the horse:</u>
- 14 (1) is a Texas-bred thoroughbred or quarter horse; and
- 15 (2) is not more than three years of age.
- 16 (d) A horse that finishes first, second, or third in a race
- 17 under this section qualifies to run in the Texas Derby race
- 18 established under Section 9A.001 of this Act.
- 19 Sec. 9A.003. INSPECTION AND EXAMINATION OF HORSE. (a) For
- 20 each qualifying race conducted under Section 9A.002 of this Act and
- 21 for the Texas Derby, the commission shall appoint a veterinarian to
- 22 supervise the inspection and examination of each horse entered in
- 23 the race to determine whether the horse is qualified to participate
- 24 in the race.
- 25 (b) The commission, in consultation with veterinarians,
- 26 shall by rule establish a list of documentation that must be
- 27 presented to the veterinarian appointed under Subsection (a) of

- 1 this section for each race to demonstrate that the horse is
- 2 qualified to run in the race.
- 3 Sec. 9A.004. TEXAS DERBY PURSE FUND. (a) The commission
- 4 shall establish a Texas Derby purse fund.
- 5 (b) The commission shall annually contribute \$3 million to
- 6 the Texas Derby purse fund from money allocated and available to the
- 7 commission for any purpose, including money specifically dedicated
- 8 to purse funds.
- 9 (c) A horse racing association conducting a qualifying race
- 10 under Section 9A.002 of this Act or the Texas Derby shall:
- 11 (1) collect an entry fee from each owner of a horse
- 12 entered in the race; and
- 13 (2) remit to the commission a portion of the fees in
- 14 the amount determined by the commission to ensure that the purse for
- 15 the Texas Derby is at least \$5 million, including the amount
- 16 <u>contributed by the commission.</u>
- 17 (d) The commission shall adopt rules for accounting, audit,
- 18 and distribution of money from the Texas Derby purse fund to winners
- 19 of the race.
- 20 SECTION 2. Notwithstanding Section 9A.004, Texas Racing Act
- 21 (Article 179e, Vernon's Texas Civil Statutes), as added by this
- 22 Act, the Texas Racing Commission may not contribute to the Texas
- 23 Derby purse fund before January 1, 2013.
- SECTION 3. This Act takes effect September 1, 2009.
