- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4
- 5 SECTION 1. Section 22.001(a), Government Code, is amended to read as follows:
- 7 (a) The supreme court has appellate jurisdiction, except in criminal law matters, coextensive with the limits of the state and 8 9 extending to all questions of law arising in the following cases when they have been brought to the courts of appeals from appealable 10
- 12 (1) a case in which the justices of a court of appeals 13 disagree on a question of law material to the decision;
- 14 (2) a case in which one of the courts of appeals holds differently from a prior decision of another court of appeals or of 15 16 the supreme court on a question of law material to a decision of the 17 case;
- 18 subject to Section 22.0011, a case involving the construction or validity of a statute necessary to a determination 19 20 of the case;
- 21 (4)a case involving state revenue;

judgment of the trial courts:

- 22 a case in which the railroad commission is a party; (5)
- 23 and

24 (6) any other case in which it appears that an error of

- 1 law has been committed by the court of appeals, and that error is of
- 2 such importance to the jurisprudence of the state that, in the
- 3 opinion of the supreme court, it requires correction, but excluding
- 4 those cases in which the jurisdiction of the court of appeals is
- 5 made final by statute.
- 6 SECTION 2. Subchapter A, Chapter 22, Government Code, is
- 7 amended by adding Section 22.0011 to read as follows:
- 8 Sec. 22.0011. JURISDICTION REGARDING NONSUBSTANTIVE
- 9 REVISIONS. (a) This section applies to the exercise of the supreme
- 10 court's jurisdiction under Section 22.001(a)(3) if:
- 11 (1) the statute at issue in the case was enacted by the
- 12 legislature under the direction of Article III, Section 43, Texas
- 13 Constitution;
- 14 (2) the legislature declared in the Act that enacted
- 15 the statute at issue that the purpose of the enactment was to codify
- 16 or revise without substantive change statutes that individually
- 17 relate to different subjects; and
- 18 (3) the statute was prepared for the legislature's
- 19 consideration by the Texas Legislative Council under the authority
- 20 granted to the council by Section 323.007.
- 21 (b) The codification or revision of a statute to which this
- 22 section applies does not affect the meaning or effect of the
- 23 <u>statute.</u>
- (c) In interpreting and applying a codified or revised
- 25 statute to which this section applies, the supreme court shall give
- 26 the statute the same effect and meaning that was or would have been
- 27 given the statute before its codification or revision,

- 1 notwithstanding the repeal of the prior statute and regardless of
- 2 any omission or change in the codified or revised statute that the
- 3 supreme court would otherwise find to be direct, unambiguous, and
- 4 irreconcilable with the prior version of the statute. Any omission
- 5 or change in the codified or revised statute for which the court
- 6 finds no direct express evidence of legislative intent to change
- 7 the sense, meaning, or effect of the statute shall be considered to
- 8 be unintended and shall be given no effect.
- 9 SECTION 3. Subchapter C, Chapter 311, Government Code, is
- 10 amended by adding Section 311.033 to read as follows:
- 11 Sec. 311.033. INTERPRETATION AND APPLICATION OF
- 12 NONSUBSTANTIVE REVISIONS. (a) This section applies to the
- 13 interpretation or application by a court, executive branch agency,
- 14 or other entity of a statute enacted by the legislature of this
- 15 state if:
- 16 (1) the statute at issue in the case was enacted by the
- 17 legislature under the direction of Article III, Section 43, Texas
- 18 Constitution;
- 19 (2) the legislature declared in the Act that enacted
- 20 the statute at issue that the purpose of the enactment was to codify
- 21 or revise without substantive change statutes that individually
- 22 <u>relate to different subjects; and</u>
- 23 (3) the statute was prepared for the legislature's
- 24 consideration by the Texas Legislative Council under the authority
- 25 granted to the council by Section 323.007.
- 26 (b) The codification or revision of a statute to which this
- 27 section applies does not affect the meaning or effect of the

1 statute.

2 (c) In interpreting and applying a codified or revised statute to which this section applies, the court, executive branch, 3 or other entity shall give the statute the same effect and meaning 4 that was or would have been given the statute before its 5 codification or revision, notwithstanding the repeal of the prior 6 statute and regardless of any omission or change in the codified or 7 revised statute that the court, executive branch, or other entity 8 would otherwise find to be direct, unambiguous, and irreconcilable 9 with the prior version of the statute. Any omission or change in 10 the codified or revised statute for which the court, executive 11 12 branch, or other entity finds no direct express evidence of legislative intent to change the sense, meaning, or effect of the 13 14 statute shall be considered to be unintended and shall be given no 15 effect. SECTION 4. This Act takes effect immediately if it receives 16

a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this

20 Act takes effect September 1, 2009.
