4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter Z, Chapter 39, Utilities Code, is
6	amended by adding Section 39.917 to read as follows:
7	Sec. 39.917. SOLAR GENERATION INCENTIVE PROGRAM. (a) It is
8	the goal of the legislature that electric utilities administer
9	incentive programs for residential, commercial, and industrial
10	customers to increase the amount of solar generation capacity
11	installed in this state in a cost-effective, market-neutral, and
12	nondiscriminatory manner, with a goal of installing at least 3,000
13	megawatts of solar generation capacity in this state by 2020, at
14	least 1,000 of which must be distributed renewable generation as
15	defined by Section 39.916.
16	(b) The commission by rule shall:
17	(1) establish a solar generation incentive program, to
18	be implemented by electric utilities, municipally owned electric
19	utilities, and electric cooperatives;
20	(2) oversee the implementation of the program required
21	by Subdivision (1); and
22	(3) establish procedures to achieve the goal
23	established by Subsection (a).
24	(c) The rules adopted under Subsection (b) must include

1 provisions for: 2 (1) a solar generation capacity cost recovery factor to ensure timely and reasonable cost recovery for electric utility 3 expenditures under this section; 4 5 (2) recovery of the cost of electric utility programs through nonbypassable fees of not less than \$0.000636 per kilowatt 6 7 hour for residential, commercial, and industrial customers; 8 (3) awarding incentive rebates in the first year of the program of not less than: 9 10 (A) \$2.40 per watt for residential installation; (B) \$1.50 per watt for commercial installation; 11 12 and (C) \$1.10 per watt for industrial installation; 13 14 (4) reducing the rebate amounts by not less than seven 15 percent annually; 16 (5) eliminating the incentive provided by electric 17 utilities under this subsection on the date the goals established by Subsection (a) are achieved; and 18 19 (6) allowing a utility to collect up to five percent of

- 3 SECTION 3. This Act takes effect immediately if it receives
- 4 a vote of two-thirds of all the members elected to each house, as
- 5 provided by Section 39, Article III, Texas Constitution. If this
- 6 Act does not receive the vote necessary for immediate effect, this
- 7 Act takes effect September 1, 2009.
