H.B. No. 4316

A BILL TO BE ENTITLED

AN ACT

1
2 relating to the authority of Las Lomas Municipal Utility District
3 Nos. 3 and 4 of Kaufman County to undertake road projects.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 8138.102(a), Special District Local Laws
6 Code, is amended to read as follows:

7 (a) To the extent authorized by Section 52, Article III,
8 Texas Constitution, the district may construct, acquire, improve,
9 maintain, or operate macadamized, graveled, or paved roads [~~or~~
10 ~~turnpikes~~], or improvements in aid of those roads [~~or turnpikes,~~
11 ~~inside the district~~].

12 SECTION 2. The change in law made by this Act applies only
13 to Las Lomas Municipal Utility District No. 3 of Kaufman County, Las
14 Lomas Municipal Utility District No. 4 of Kaufman County, and any
15 district created under Subchapter F, Chapter 8138, Special District
16 Local Laws Code, after September 1, 2009.

17 SECTION 3. The change in law made by this Act applies only
18 to a road project that obtains consent under Section 8138.102(c),
19 Special District Local Laws Code, or a road bond issuance
20 authorized on or after the effective date of this Act. A road
21 project that obtains consent under Section 8138.102(c), Special
22 District Local Laws Code, or a road bond issuance authorized before
23 the effective date of this Act is subject to the law in effect on the
24 date of consent or authorization, and that law is continued in

1 effect for that purpose.

2 SECTION 4. (a) The legal notice of the intention to
3 introduce this Act, setting forth the general substance of this
4 Act, has been published as provided by law, and the notice and a
5 copy of this Act have been furnished to all persons, agencies,
6 officials, or entities to which they are required to be furnished
7 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
8 Government Code.

9 (b) The governor, one of the required recipients, has
10 submitted the notice and Act to the Texas Commission on
11 Environmental Quality.

12 (c) The Texas Commission on Environmental Quality has filed
13 its recommendations relating to this Act with the governor, the
14 lieutenant governor, and the speaker of the house of
15 representatives within the required time.

16 (d) All requirements of the constitution and laws of this
17 state and the rules and procedures of the legislature with respect
18 to the notice, introduction, and passage of this Act are fulfilled
19 and accomplished.

20 SECTION 5. This Act takes effect September 1, 2009.
