(b) A state official may be issued four three sets of 11 12 license plates under this section; (c) The license plates remain valid until December 31 of 13 14 each year. In this section, "state official" means: (d) 15 a member of the legislature; 16 (1) (2) the governor; 17 18 (3) the lieutenant governor; a justice of the supreme court; (4) 19 a judge of the court of criminal appeals; 20 (5)21 (6) the attorney general; 22 (5) (7) the Commissioner of the General Land Office; (6) (8) the comptroller; 23 (7) (9) a member of the Railroad Commission of Texas; 24

H.B. No. 4383 (8) (10) the commissioner of agriculture; 1 2 (9) (11) the secretary of state; or 3 (10) (12) a member of the State Board of Education. 4 SECTION 2. Chapter 504 of the Transportation Code is 5 amended by adding Section 504.401B to read as follows: 6 Sec.504.401B - STATE OFFICIALS - JUDICIAL BRANCH. (a) The 7 department shall issue without charge specialty license plates for a current state judge. The license plates must include the words 8 9 "State Judge." 10 (b) A person may be issued three sets of plates under this section. 11 12 (c) The license plates remain valid until December 31 of 13 each year. 14 (d) In this section, a "state judge" includes: 15 (1) a justice of the supreme court; 16 (2) a judge of the court of criminal appeals; 17 (3) a judge of a court of appeals; (4) a district court judge; 18 19 (5) a presiding judge of an administrative judicial district; or 20 21 (6) <u>a judge of a statutory county court.</u> SECTION 3. Section 504.402, Transportation Code, is amended 2.2 23 to read as follows: 24 Sec.504.402A. FEDERAL OFFICIALS - LEGISLATIVE BRANCH. (a) 25 The department shall issue without charge specialty license plates 26 for members of congress. License plates issued under this section must include the words "U.S. Congress." 27

H.B. No. 4383 1 (b) A person may be issued <u>four</u> three sets of license plates under this section. 2 The license plates remain valid until December 31 of 3 (C) each year. 4 SECTION 4. Chapter 504 of the Transportation Code 5 is amended by adding Section 504.402B to read as follows: 6 Sec.504.402B - FEDERAL OFFICIALS - JUDICIAL BRANCH. (a) The 7 department shall issue without charge specialty license plates for 8 a current federal judge. The license plates must include the words 9 "U.S. Judge." 10 (b) A person may be issued three sets of plates under this 11 12 section. The license plates remain valid until December 31 of 13 (c) 14 each year. 15 (d) In this section, a "federal judge" includes: (1) a justice of the United States Supreme Court whose 16 17 primary residence is in Texas; 18 (2) a judge of the Fifth Circuit Court of Appeals; or 19 (3) a judge of a United States district. 20 SECTION 5. Section 504.403 and Section 504.404, Transportation Code, are repealed. 21 SECTION 6. Chapter 504, Transportation Code, is amended by 22 adding Section 504.403A to read as follows: 23 24 Section 504.403A. COUNTY OFFICIALS - COUNTY JUDGES. (a) 25 The department shall issue without charge specialty license plates 26 for current county judges of this state. The license plates shall bear the words "County Judge." 27

1 (b) A person may be issued two sets of license plates under this section. 2 (c) 3 The license plates remain valid until December 31 of 4 each year. 5 (c) In this section, "county judge" means the judge of the county court established under Section 15, Article V, of the Texas 6 7 Constitution. 8 SECTION 7. Chapter 504, Transportation Code, is amended by adding Section 504.403B to read as follows: 9 Section 504.403B. COUNTY OFFICIALS - SHERIFFS. (a) The 10 department shall issue without charge specialty license plates for 11 12 current county sheriffs of this state. The license plates shall bear the words "County Sheriff." 13 14 (b) A person may be issued one set of license plates under 15 this section. (c) The license plates remain valid until December 31 of 16 17 each year. SECTION 7. Chapter 504, Transportation Code, is amended by 18 adding Section 504.403B to read as follows: 19 Section 504.403C. COUNTY OFFICIALS - CONSTABLES. (a) The 20 department shall issue without charge specialty license plates for 21 current county constables of this state. The license plates shall 22 bear the words "County Constable." 23 24 (b) A person may be issued one set of license plates under this section. 25 26 (c) The license plates remain valid until December 31 of 27 each year.
