- 5 SECTION 1. Heading of Chapter 383 of Title 12 of the Local
- 6 Government Code, is amended to read as follows:
- 7 CHAPTER 383. COUNTY <u>ECONOMIC</u> DEVELOPMENT DISTRICTS.
- 8 SECTION 2. Section 383.001, Local Government Code, is
- 9 amended to read as follows:
- 10 Sec. 383.002. LEGISLATIVE INTENT. This chapter furthers
- 11 the public purpose of developing and diversifying the economy of
- 12 this state by providing incentives for the location and development
- 13 of projects in certain counties to promote economic development and
- 14 to attract visitors and tourists.
- 15 SECTION 3. Section 383.003, Local Government Code, amends
- 16 Subsections (a) and (c) to read as follows:
- 17 Sec. 383.003. FINDINGS. (a) Small and medium-sized
- 18 Counties in this state need incentives for the development of
- 19 public improvements and projects to promote economic development
- 20 <u>and</u> to attract visitors and tourists to those counties, and those
- 21 counties are at a disadvantage in competing with counties in other
- 22 states for the location and development of projects that attract
- 23 visitors by virtue of the availability and prevalent use of
- 24 financial incentives in other states.

- 1 (c) The creation of <u>economic</u> development districts is
- 2 essential to the accomplishment of Section 52-a, Article III, Texas
- 3 Constitution, and to the accomplishment of the other public

- 7 SECTION 4. Section 383.021, Local Government Code, is
- 8 amended to read as follows:
- 9 Sec. 383.021. COUNTIES AUTHORIZED TO CREATE DISTRICTS.
- 10 (a) The commissioners court of a county with a population of
- 11 400,000 or less, on petition of the owners of land in a proposed
- 12 district, may commence the creation of a county economic
- 13 development district.
- SECTION 5. Section 383.023(2), Local Government Code, is
- 15 amended to read as follows:
- 16 (2) include a name for the proposed district, which
- 17 must include the name of the county followed by the words "Economic
- 18 Development District No._____";.
- 19 SECTION 6. Section 383.033(b), Local Government Code, is
- 20 amended to read as follows:
- 21 (b) The ballot shall be printed to permit voting for or
- 22 against the proposition: "The creation of _____ County
- 23 <u>Economic</u> Development District No. _____ and the adoption of a
- 24 proposed local sales and use tax rate of _____ (the rate specified
- 25 in the election order) to be used for the promotion and development
- 26 of tourism and economic development."
- 27 SECTION 7. This Act takes effect September 1, 2009.
