4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. HARRIS COUNTY IMPROVEMENT DISTRICT NO. 11.
6	Subtitle C, Title 4, Special District Local Laws Code, is amended by
7	adding Chapter 3878 to read as follows:
8	CHAPTER 3878. HARRIS COUNTY IMPROVEMENT DISTRICT NO. 11
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 3878.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the board of directors of the
12	district.
13	(2) "District" means the Harris County Improvement
14	District No. 11.
15	Sec. 3878.002. HARRIS COUNTY IMPROVEMENT DISTRICT NO.
16	11. The Harris County Improvement District No. 11 is a special
17	district created under Section 59, Article XVI, Texas Constitution.
18	Sec. 3878.003. PURPOSE; DECLARATION OF INTENT. (a) The
19	creation of the district is essential to accomplish the purposes of
20	Sections 52 and 52-a, Article III, and Section 59, Article XVI,
21	Texas Constitution, and other public purposes stated in this
22	chapter. By creating the district and in authorizing Harris
23	County, the City of Houston, the Metropolitan Transit Authority of

Harris County, and other political subdivisions to contract with

- 1 the district, the legislature has established a program to
- 2 accomplish the public purposes set out in Section 52-a, Article
- 3 III, Texas Constitution.
- 4 (b) The creation of the district is necessary to promote,
- 5 develop, encourage, and maintain employment, commerce,
- 6 transportation, housing, tourism, recreation, the arts,
- 7 entertainment, economic development, safety, and the public
- 8 welfare in the area of the district.
- 9 (c) This chapter and the creation of the district may not be
- 10 interpreted to relieve Harris County or the City of Houston from
- 11 providing the level of services provided as of the effective date of
- 12 this Act to the area in the district or to release the county or the
- 13 city from the obligations of each entity to provide services to that
- 14 area. The district is created to supplement and not to supplant the
- 15 county or city services provided in the area in the district.
- Sec. 3878.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a)
- 17 The district is created to serve a public use and benefit.
- 18 (b) All land and other property included in the district
- 19 will benefit from the improvements and services to be provided by
- 20 the district under powers conferred by Sections 52 and 52-a,
- 21 Article III, and Section 59, Article XVI, Texas Constitution, and
- 22 other powers granted under this chapter.
- (c) Each improvement project or service authorized by this
- 24 chapter is essential to carry out a public purpose.
- 25 (d) The creation of the district is in the public interest
- 26 and is essential to:
- 27 (1) further the public purposes of developing and

diversifying the economy of the state; 2 (2) eliminate unemployment and underemployment; and 3 (3) develop or expand transportation and commerce. 4 (e) The district will: 5 (1) promote the health, safety, and general welfare of residents, employers, employees, visitors, and consumers in the 6 7 district, and of the public; 8 (2) provide needed funding for the district to preserve, maintain, and enhance the economic health and vitality of 9 10 the area as a community and business center; 11 (3) promote the health, safety, welfare, and enjoyment 12 of the public by providing public art and pedestrian ways and by landscaping and developing certain areas in the district, which are 13 necessary for the restoration, preservation, and enhancement of 14 15 scenic and aesthetic beauty; 16 (4) promote and benefit commercial development and 17 commercial areas in the district; and (5) promote and develop public transportation and 18 19 pedestrian facilities and systems using new and alternative means that are attractive, safe, and convenient, including securing 20 expanded and improved transportation and pedestrian facilities and 21 22 systems, to: 23 (A) address the problem of traffic congestion in 24 the district, the need to control traffic and improve pedestrian safety, and the limited availability of money; and 25 26 (B) benefit the land and other property in the district and the residents, employers, employees, visitors, and 27

- 1 consumers in the district and the public.
- 2 (f) Pedestrian ways along or across a street, whether at
- 3 grade or above or below the surface, and street lighting, street
- 4 landscaping, and street art objects are parts of and necessary
- 5 components of a street and are considered to be a street or road
- 6 improvement.
- 7 (g) The district will not act as the agent or
- 8 instrumentality of any private interest even though the district
- 9 will benefit many private interests as well as the public.
- Sec. 3878.005. DISTRICT TERRITORY. (a) The district is
- 11 composed of the territory described by Section 2 of the Act enacting
- 12 this chapter, as that territory may have been modified under:
- 13 (1) Section 3878.251;
- 14 (2) Subchapter J, Chapter 49, Water Code; or
- 15 (3) other law.
- 16 (b) The boundaries and field notes of the district contained
- 17 in Section 2 of the Act enacting this chapter form a closure. A
- 18 mistake in the field notes or in copying the field notes in the
- 19 legislative process does not in any way affect:
- 20 (1) the district's organization, existence, and
- 21 validity;
- (2) the district's right to issue any type of bond,
- 23 including a refunding bond, for a purpose for which the district is
- 24 created or to pay the principal of and interest on the bond;
- 25 <u>(3) the district's right to impose and collect an</u>
- 26 assessment or tax; or
- 27 (4) the legality or operation of the district or the

- 1 board.
- 2 (c) A description of the district's boundaries shall be
- 3 filed with the Texas Commission on Environmental Quality. The
- 4 commission by order may correct a mistake in the description of the
- 5 district's boundaries.
- 6 Sec. 3878.006. TORT LIABILITY. The district is a
- 7 governmental unit under Chapter 101, Civil Practice and Remedies
- 8 Code, and the operations of the district are essential government
- 9 functions and are not proprietary functions for any purpose,
- 10 including the application of that chapter.
- 11 Sec. 3878.007. LIBERAL CONSTRUCTION OF CHAPTER. This
- 12 chapter shall be liberally construed in conformity with the
- 13 <u>findings and purposes stated</u> in this chapter.
- 14 [Sections 3878.008-3878.050 reserved for expansion]
- SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 3878.051. BOARD OF DIRECTORS; TERMS. (a) The district
- 17 is governed by a board of five voting directors appointed by a
- 18 majority of the members of the governing body, including the mayor,
- 19 of the City of Houston. Voting directors serve staggered terms of
- 20 four years with two or three directors' terms expiring June 1 of
- 21 <u>each odd-numbered year.</u>
- 22 (b) The board by order or resolution may increase or
- 23 decrease the number of voting directors on the board, but only if a
- 24 majority of the voting directors finds that it is in the best
- 25 <u>interest of the district to do so. The board may not:</u>
- 26 (1) increase the number of voting directors to more
- 27 than nine; or

(2) decrease the number of voting directors to fewer 1 2 than five. 3 (c) Sections 49.053, 49.054, 49.056, 49.057, 49.058, and 49.060, Water Code, apply to the board. 4 (d) Subchapter D, Chapter 375, Local Government Code, 5 applies to the board to the extent that subchapter does not conflict 6 with this chapter. 7 8 Sec. 3878.052. APPOINTMENT OF DIRECTORS ON INCREASE IN BOARD SIZE. If the board increases the number of directors under 9 Section 3878.051, the board shall appoint eligible persons to fill 10 the new director positions and shall provide for the staggering of 11 12 terms of the new directors. On expiration of the term of a director appointed under this section, a succeeding director shall be 13 14 appointed and qualified as provided by Subchapter D, Chapter 375, 15 Local Government Code. The mayor and members of the governing body of the City of Houston shall appoint voting directors from persons 16 17 recommended by the board. A person is appointed if a majority of the members of the governing body, including the mayor, vote to 18 19 appoint that person. Sec. 3878.053. NONVOTING DIRECTORS. (a) The following 20 persons shall serve as nonvoting directors: 21 22 (1) the directors of the following departments of the City of Houston or a person designated by that director: 23 24 (A) parks and recreation; 25 (B) planning and development; and 26 (C) public works; and 27 (2) the City of Houston's chief of police.

- 1 (b) If a department described by Subsection (a) is
- 2 consolidated, renamed, or changed, the board may appoint a director
- 3 of the consolidated, renamed, or changed department as a nonvoting
- 4 director. If a department described by Subsection (a) is
- 5 abolished, the board may appoint a representative of another
- 6 department that performs duties comparable to the duties performed
- 7 by the abolished department.
- 8 Sec. 3878.054. QUORUM. (a) A majority of the voting
- 9 directors constitutes a quorum of the board.
- 10 (b) Nonvoting directors and vacant director positions are
- 11 not counted for the purposes of establishing a quorum of the board.
- 12 Sec. 3878.055. CONFLICTS OF INTEREST; ONE-TIME AFFIDAVIT.
- 13 (a) Except as provided by this section:
- 14 (1) a voting director may participate in all board
- 15 votes and decisions; and
- 16 (2) Chapter 171, Local Government Code, governs
- 17 conflicts of interest for directors.
- 18 (b) Section 171.004, Local Government Code, does not apply
- 19 to the district. A director who has a substantial interest in a
- 20 business or charitable entity that will receive a pecuniary benefit
- 21 from a board action shall file a one-time affidavit declaring the
- 22 interest. An additional affidavit is not required if the
- 23 director's interest changes. After the affidavit is filed with the
- 24 board secretary, the director may participate in a discussion or
- 25 vote on that action if:
- 26 (1) a majority of the directors have a similar
- 27 interest in the same entity; or

(2) all other similar <u>business or charitable entities</u>

         (c) A director who is also an officer or employee of a public

2	Sec. 3878.101. DISTRICT POWERS. The district may exercise
3	the powers given to:
4	(1) a district created under Chapter 375, Local
5	Government Code;
6	(2) a district by Subchapters H and I, Chapter 49,
7	Water Code;
8	(3) a corporation under Chapter 505, Local Government
9	Code, including the power to own, operate, acquire, construct,
10	lease, improve, and maintain the projects described by that
11	section; and
12	(4) a housing finance corporation created under
13	Chapter 394, Local Government Code, to provide housing or
14	residential development projects in the district.
15	Sec. 3878.102. NONPROFIT CORPORATION. (a) The board by
16	resolution may authorize the creation of a nonprofit corporation to
17	assist and act for the district in implementing a project or
18	providing a service authorized by this chapter.
19	(b) The nonprofit corporation:
20	(1) has each power of and is considered for purposes of
21	this chapter to be a local government corporation created under
22	Chapter 431, Transportation Code; and
23	(2) may implement any project and provide any service
24	authorized by this chapter.

- 4 Sec. 3878.103. AGREEMENTS; GRANTS. (a) The district may
- 5 make an agreement with or accept a gift, grant, or loan from any
- 6 person.
- 7 (b) The implementation of a project is a governmental
- 8 function or service for the purposes of Chapter 791, Government
- 9 Code.
- Sec. 3878.104. ELECTIONS. (a) District elections must be
- 11 held in the manner provided by Subchapter L, Chapter 375, Local
- 12 Government Code.
- 13 (b) The board may submit multiple purposes in a single
- 14 proposition at an election.
- 15 Sec. 3878.105. CONTRACT FOR LAW ENFORCEMENT AND SECURITY
- 16 SERVICES. The district may contract with:
- 17 (1) Harris County or the City of Houston for the county
- 18 or city to provide law enforcement and security services in the
- 19 district for a fee; or
- 20 (2) a private entity for the private entity to provide
- 21 <u>supplemental security services.</u>
- Sec. 3878.106. ANNEXATION OR EXCLUSION OF TERRITORY. The
- 23 district may annex or exclude land from the district in the manner
- 24 provided by Subchapter C, Chapter 375, Local Government Code.
- Sec. 3878.107. APPROVAL BY CITY OF HOUSTON. (a) Except as
- 26 provided by Subsection (b), the district must obtain the approval
- 27 of the City of Houston's governing body for:

- 1 (1) the issuance of a bond for each improvement
- 2 project;
- 3 (2) the plans and specifications of the improvement
- 4 project financed by the bond; and
- 5 (3) the plans and specifications of any district
- 6 improvement project related to the use of land owned by the City of
- 7 Houston, an easement granted by the City of Houston, or a
- 8 right-of-way of a street, road, or highway.
- 9 (b) If the district obtains the approval of the City of
- 10 Houston's governing body of a capital improvements budget for a
- 11 period not to exceed five years, the district may finance the
- 12 capital improvements and issue bonds specified in the budget
- 13 without further approval from the City of Houston.
- 14 Sec. 3878.108. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The
- 15 district may join and pay dues to an organization that:
- (1) enjoys tax-exempt status under Section 501(c)(3),
- 17 (4), or (6), Internal Revenue Code of 1986; and
- 18 (2) performs a service or provides an activity
- 19 consistent with promoting a district purpose.
- Sec. 3878.109. ROAD POWERS. The district may exercise
- 21 powers given to:
- 22 (1) a road district created under Chapter 257,
- 23 Transportation Code; and
- 24 (2) a road utility district created under Chapter 441,
- 25 Transportation Code.
- Sec. 3878.110. AIR RIGHTS; CONSTRUCTION. The district may
- 27 acquire air rights and related easements and may construct

- 1 improvements on property on which it owns only air rights and
- 2 related easements.
- 3 Sec. 3878.111. ADDITIONAL PROPERTY RIGHTS; LEASEHOLDS. The
- 4 district may construct improvements on property on which it only
- 5 has a leasehold interest and may own undivided interests in
- 6 buildings and other improvements.
- 7 Sec. 3878.112. NO EMINENT DOMAIN POWER. The district may
- 8 not exercise the power of eminent domain.
- 9 [Sections 3878.113-3878.150 reserved for expansion]
- 10 SUBCHAPTER D. PUBLIC TRANSIT SYSTEM AND PARKING FACILITIES
- 11 Sec. 3878.151. PUBLIC TRANSIT SYSTEM; PETITION REQUIRED.
- 12 (a) The district may acquire, lease as lessor or lessee, construct,
- 13 develop, own, operate, and maintain a public transit system to
- 14 serve the area within the boundaries of the district.
- 15 (b) The board may not act under Subsection (a) unless a
- 16 written petition requesting the action has been filed with the
- 17 board.
- 18 (c) The petition must be signed by:
- 19 <u>(1)</u> the owners of property representing a majority of
- 20 the total assessed value of the real property in the district that
- 21 abuts the right-of-way in which the public transit system is
- 22 proposed to be located; or
- 23 (2) the owners of a majority of the area of the real
- 24 property in the district that abuts the right-of-way in which the
- 25 public transit system is proposed to be located.
- 26 (d) For purposes of Subsection (c), the determination of a
- 27 majority is based on the property owners along the entire

- 1 right-of-way of the proposed transit project and may not be
- 2 calculated on a block-by-block basis.
- 3 Sec. 3878.152. PARKING FACILITIES AUTHORIZED; OPERATION BY
- 4 PRIVATE ENTITY; TAX EXEMPTION. (a) The district may acquire, lease
- 5 <u>as lessor or lessee, construct, develop, own, operate, and maintain</u>
- 6 parking facilities, including:
- 7 (1) lots, garages, parking terminals, or other
- 8 structures or accommodations for the parking of motor vehicles; and
- 9 (2) equipment, entrances, exits, fencing, and other
- 10 accessories necessary for safety and convenience in the parking of
- 11 vehicles.
- 12 (b) A parking facility of the district must be either leased
- 13 to or operated on behalf of the district by a private entity or an
- 14 entity other than the district. The district's parking facilities
- 15 are a program authorized by the legislature under Section 52-a,
- 16 Article III, Texas Constitution, and accomplish a public purpose
- 17 under that section even if leased or operated by a private entity
- 18 for a term of years.
- 19 (c) The district's public parking facilities and any lease
- 20 to a private entity are exempt from the payment of ad valorem taxes
- 21 and state and local sales and use taxes.
- 22 Sec. 3878.153. RULES. The district may adopt rules
- 23 covering its public transit system or its public parking
- 24 facilities, except that a rule relating to or affecting the use of
- 25 the public right-of-way or a requirement for off-street parking is
- 26 subject to all applicable municipal charter, code, or ordinance
- 27 requirements.

- 1 Sec. 3878.154. FINANCING OF PUBLIC TRANSIT SYSTEM OR
- 2 PARKING FACILITIES. (a) The district may use any of its resources,
- 3 <u>including revenue</u>, assessments, taxes, and grant or contract
- 4 proceeds, to pay the cost of acquiring and operating a public
- 5 transit system or public parking facilities.
- 6 (b) The district may set and impose fees, charges, or tolls
- 7 for the use of the public transit system or the public parking
- 8 <u>facilities and may issue bonds or notes to finance the cost of these</u>
- 9 facilities.
- 10 (c) Except as provided by Section 3878.151, if the district
- 11 pays for or finances the cost of acquiring or operating a public
- 12 transit system or public parking facilities with resources other
- 13 than assessments, a petition of property owners or a public hearing
- 14 is not required.
- 15 Sec. 3878.155. PAYMENT IN LIEU OF TAXES TO OTHER TAXING
- 16 UNIT. If the district's acquisition of property for a parking
- 17 facility that is leased to or operated by a private entity results
- 18 in the removal from a taxing unit's tax rolls of real property
- 19 otherwise subject to ad valorem taxation, the district shall pay to
- 20 the taxing unit in which the property is located, on or before
- 21 January 1 of each year, as a payment in lieu of taxes, an amount
- 22 equal to the ad valorem taxes that otherwise would have been imposed
- 23 for the preceding tax year on that real property by the taxing unit,
- 24 <u>without</u> including the value of any improvements constructed on the
- 25 property.
- Sec. 3878.156. AGREEMENT WITH RAPID TRANSIT AUTHORITY. (a)
- 27 In this section, "authority" means a rapid transit authority

- 1 created under Chapter 451, Transportation Code.
- 2 (b) The district and an authority may agree to jointly
- 3 construct, own, operate, and maintain a transit facility or a
- 4 parking facility under the terms the authority and district desire.
- 5 (c) The agreement may provide that the district and the
- 6 authority exchange or trade land provided that each party to the
- 7 agreement receives fair market value. The authority is not
- 8 required to offer any property that it proposes to trade to the
- 9 district for sale to the public or for sale to any abutting property
- 10 owner.
- [Sections 3878.157-3878.200 reserved for expansion]
- 12 SUBCHAPTER E. FINANCIAL PROVISIONS
- Sec. 3878.201. AUTHORITY TO IMPOSE ASSESSMENTS, AD VALOREM
- 14 TAXES, AND IMPACT FEES. The district may impose, assess, charge, or
- 15 collect an assessment, an ad valorem tax, an impact fee, or another
- 16 fee in accordance with Chapter 49, Water Code, for a purpose
- 17 specified by Chapter 375, Local Government Code, or as needed to
- 18 exercise a power or function of the district or to accomplish a
- 19 purpose or duty for which the district was created.
- 20 <u>Sec. 3878.202.</u> <u>DISBURSEMENTS AND TRANSFERS OF MONEY.</u> The
- 21 board by resolution shall establish the number of directors'
- 22 signatures and the procedure required for a disbursement or
- 23 transfer of the district's money.
- Sec. 3878.203. ASSESSMENT IN PART OF DISTRICT. An
- 25 assessment may be imposed on only a part of the district if only
- 26 that part will benefit from the service or improvement.
- Sec. 3878.204. PETITION REQUIRED FOR ASSESSMENT AND FOR

- 1 FINANCING SERVICES AND IMPROVEMENTS. (a) The board may not impose
- 2 an assessment or finance a service or improvement project under
- 3 this chapter unless a written petition requesting the improvement
- 4 or service has been filed with the board.
- 5 (b) The petition must be signed by:
- 6 (1) the owners of a majority of the assessed value of
- 7 real property in the district subject to assessment according to
- 8 the most recent certified tax appraisal roll for Harris County; or
- 9 (2) at least 25 owners of real property in the district
- 10 that will be subject to the assessment, if more than 25 persons own
- 11 real property subject to the assessment in the district according
- 12 to the most recent certified tax appraisal roll for Harris County.
- 13 (c) The board may act upon a petition, required under this
- 14 section, signed by qualified petitioners prior to or subsequent to
- 15 the enactment of this chapter.
- Sec. 3878.205. ASSESSMENTS CONSIDERED TAXES. For purposes
- 17 of a title insurance policy issued under Title 11, Insurance Code,
- 18 an assessment is a tax.
- 19 Sec. 3878.206. MAINTENANCE TAX. (a) If authorized at an
- 20 election held in accordance with Section 3878.104, the district may
- 21 impose an annual ad valorem tax on taxable property in the district
- 22 <u>to:</u>
- 23 <u>(1) administer the district;</u>
- 24 (2) maintain and operate the district;
- 25 (3) construct or acquire improvements; or
- 26 (4) provide a service.
- 27 (b) The board shall determine the tax rate.

- 1 (c) An owner of real property in the district, except
- 2 property exempt under the Texas or United States Constitution or
- 3 under the Tax Code, is liable for the payment of ad valorem taxes
- 4 <u>imposed by the district on the property.</u>
- 5 Sec. 3878.207. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)
- 6 The board by resolution may impose and collect an assessment for any
- 7 purpose authorized by this chapter.
- 8 <u>(b) An assessment, a reassessment, or an assessment</u>
- 9 resulting from an addition to or correction of the assessment roll
- 10 by the district, penalties and interest on an assessment or
- 11 reassessment, an expense of collection, and reasonable attorney's
- 12 fees incurred by the district:
- 13 <u>(1) are a first and prior lien against the property</u>
- 14 assessed;
- 15 (2) are superior to any other lien or claim other than
- 16 a lien or claim for county, school district, or municipal ad valorem
- 17 taxes; and
- 18 (3) are the personal liability of and a charge against
- 19 the owners of the property even if the owners are not named in the
- 20 assessment proceedings.
- 21 <u>(c)</u> The lien is effective from the date of the board's
- 22 resolution imposing the assessment until the date the assessment is
- 23 paid. The board may enforce the lien in the same manner that the
- 24 board may enforce an ad valorem tax lien against real property.
- 25 (d) The board may make a correction to or deletion from the
- 26 assessment roll that does not increase the amount of assessment of
- 27 any parcel of land without providing notice and holding a hearing in

- 1 the manner required for additional assessments.
- 2 Sec. 3878.208. PROPERTY OF CERTAIN UTILITIES EXEMPT FROM
- 3 ASSESSMENT AND IMPACT FEES. The district may not impose an impact
- 4 fee or assessment on the property, including the equipment,
- 5 rights-of-way, facilities, or improvements, of:
- 6 (1) an electric utility or a power generation company
- 7 <u>as defined by Section 31.002, Utilities Code;</u>
- 8 (2) a gas utility as defined by Section 101.003 or
- 9 121.001, Utilities Code;
- 10 (3) a telecommunications provider as defined by
- 11 Section 51.002, Utilities Code; or
- 12 (4) a person who provides the public cable television

- 15 district may impose an assessment to pay the cost of:

- 18 electrical or optical line;
- 19 (2) removing poles and any elevated lines using the
- 20 poles; and
- 21 (3) reconnecting the lines described by Subdivision

- 24 (b) The district may acquire, operate, or charge fees for

 3 (2) any other type of transmission line of

- 5 (c) The district may not require a person to use a district
- 6 <u>conduit.</u>
- 7 Sec. 3878.210. BONDS AND OTHER OBLIGATIONS. (a) The
- 8 district may issue bonds, notes, or other obligations in accordance
- 9 with Subchapter J, Chapter 375, Local Government Code, payable
- 10 wholly or partly from assessments, impact fees, revenue, grants, or
- 11 other money of the district, or any combination of these sources of
- 12 money, to pay for any authorized district purpose.
- 13 (b) In exercising the district's power to borrow, the
- 14 district may issue a bond or other obligation in the form of a bond,
- 15 note, certificate of participation or other instrument evidencing a
- 16 proportionate interest in payments to be made by the district, or
- 17 other type of obligation.
- Sec. 3878.211. LIMITS ON PARKS AND RECREATION BONDS. Bonds
- 19 issued to finance parks and recreational facilities may not exceed
- 20 one percent of the assessed value of the real property in the
- 21 district according to the most recent certified tax appraisal roll
- 22 <u>for Harris County.</u>
- Sec. 3878.212. TAX AND BOND ELECTIONS. (a) The district
- 24 shall hold an election in the manner provided by Subchapter L,
- 25 Chapter 375, Local Government Code, to obtain voter approval before
- 26 the district imposes a maintenance tax or issues bonds payable from
- 27 ad valorem taxes.

- 1 (b) The board may not include more than one purpose in a
- 2 single proposition at an election.
- 3 (c) Section 375.243, Local Government Code, does not apply
- 4 to the district.
- 5 Sec. 3878.213. POWERS OF MUNICIPAL UTILITY DISTRICT TO
- 6 ESTABLISH DEFINED AREAS AND DESIGNATED PROPERTY; TAXES; BONDS. (a)
- 7 The district has the powers of a municipal utility district under
- 8 Subchapter J, Chapter 54, Water Code, including the power to:
- 9 (1) implement a plan;
- 10 (2) issue bonds; and
- 11 (3) impose a tax in a defined area established under
- 12 that subchapter.
- 13 (b) The district may exercise the powers described by
- 14 Subsection (a) regardless of whether the district is composed of
- 15 the minimum number of acres provided by Section 54.801, Water Code.
- 16 Sec. 3878.214. MUNICIPALITY NOT REQUIRED TO PAY DISTRICT
- 17 OBLIGATIONS. Except as provided by Section 375.263, Local
- 18 Government Code, a municipality is not required to pay a bond, note,
- 19 or other obligation of the district.
- Sec. 3878.215. COMPETITIVE BIDDING. Section 375.221, Local
- 21 Government Code, applies to the district only for a contract that
- 22 has a value greater than \$50,000.
- 23 [Sections 3878.216-3878.250 reserved for expansion]
- SUBCHAPTER F. CONSOLIDATION
- Sec. 3878.251. CONSOLIDATION WITH MUNICIPAL MANAGEMENT
- 26 DISTRICT. (a) The district may consolidate with one or more other
- 27 municipal management districts that are adjoining or have a

- 1 boundary that is within a two-mile radius of any boundary of the
- 2 district. The board may consolidate with one or more other
- 3 districts only if none of the districts to be consolidated has
- 4 issued bonds or notes secured by assessments or ad valorem taxes or
- 5 has imposed taxes.
- 6 (b) To initiate consolidation, the board of a district shall
- 7 adopt a resolution proposing a consolidation and deliver a copy of
- 8 the resolution to the board of each district with which
- 9 consolidation is proposed.
- 10 Sec. 3878.252. TERMS AND CONDITIONS FOR CONSOLIDATION. Not
- 11 later than the 30th day after districts are consolidated under
- 12 Section 3878.251, the districts shall enter into an agreement
- 13 specifying the terms and conditions for consolidation. The terms
- 14 and conditions for consolidation must include:
- 15 (1) adoption of a name for the consolidated district;

- 25 Each district's board shall publish notice and hold a public
- 26 hearing in its district regarding the terms and conditions for
- 27 consolidation of the districts. The board shall publish notice at

- 1 least once in a newspaper with general circulation in the affected
- 2 districts at least seven days before the hearing.
- 3 (b) After the hearing, each board by resolution must approve
- 4 the terms and conditions for consolidation by majority vote and
- 5 enter an order consolidating the districts.
- 6 (c) If the board of each involved district adopts a
- 7 resolution containing the terms and conditions for the
- 8 consolidation, the involved districts become consolidated.
- 9 Sec. 3878.254. GOVERNING CONSOLIDATED DISTRICTS. (a)
- 10 After two or more districts are consolidated, they become one
- 11 district and are governed as one district.
- 12 (b) During the period before the terms and conditions of the
- 13 agreement under Section 3878.252 take effect, the officers of each
- 14 district shall continue to act jointly as officers of the original
- 15 <u>districts to settle the affairs of their respective districts.</u>
- Sec. 3878.255. DEBTS OF ORIGINAL DISTRICTS. After two or
- 17 more districts are consolidated, the consolidated district shall
- 18 protect the debts and obligations of the original districts and
- 19 shall ensure that the debts and obligations are not impaired. If
- 20 the consolidated district has taxing authority, the debts may be
- 21 paid by taxes imposed on the land in the original districts as if
- 22 they had not consolidated or from contributions from the
- 23 consolidated district on terms stated in the consolidation
- 24 agreement.
- Sec. 3878.256. ASSESSMENT AND COLLECTION OF TAXES. If the
- 26 consolidated district has taxing authority, the district shall
- 27 impose and collect taxes on all property in the district uniformly,

- 1 for maintenance and operation of the district.
- 2 Sec. 3878.257. FILING OF ORDER WITH COUNTY CLERK AND
- 3 EXECUTIVE DIRECTOR. The board shall keep in the records of the
- 4 consolidated district, recorded in the office of the county clerk
- 5 in each of the counties in the consolidated district, a
- 6 consolidation order issued by the board. The board shall file the
- 7 consolidation order with the executive director of the Texas
- 8 Commission on Environmental Quality.
- 9 [Sections 3878.258-3878.300 reserved for expansion]
- 10 <u>SUBCHAPTER G. DISSOLUTION</u>
- 11 Sec. 3878.301. DISSOLUTION OF DISTRICT WITH OUTSTANDING
- 12 DEBT. (a) The district may be dissolved as provided by Subchapter
- 13 M, Chapter 375, Local Government Code, except that Section 375.264,
- 14 Local Government Code, does not apply to the district. The board
- 15 may dissolve the district regardless of whether the district has
- 16 <u>debt.</u>
- 17 (b) If the district has debt when it is dissolved, the
- 18 district shall remain in existence solely for the purpose of
- 19 discharging its bonds or other obligations according to their
- 20 terms. The dissolution is effective when all debts have been

- 19 Graustark.
- 20 Thence in a southerly direction along the center right of way of
- 21 Graustark to the center right of way of U.S. Highway 59.
- 22 Thence easterly along the center right of way of US 59 South to the
- 23 north property line of Tract 12, Block 7 MacGregor Blodgett Section
- 24 1;
- 25 Thence southwesterly along the north property line of Tracts 12 and
- 26 10, Block 7 MacGregor Blodgett Section 1;
- 27 Thence southwesterly along the north property line of Tract 9,

- 1 Block 8 MacGregor Blodgett Section 1 to the south east property line
- 2 of the C.C. Fitze Homestead Addition according to the plat thereof
- 3 recorded in Volume 259, Page 163 of the Harris County Deed Records;
- 4 Thence south westerly along the south east property line of said
- 5 C.C. Fitze Homestead Addition according to the plat thereof
- 6 recorded in Volume 259, Page 163 of the Harris County Deed Records;
- 7 Thence westerly along the south property line of said C.C. Fitze
- 8 Homestead Addition according to the plat thereof recorded in Volume

- 10 dead end of Travis to the center right of way line thereof;
- 11 Thence southwesterly along the center right of way line of Travis to

- 26 SECTION 3. REIMBURSEMENT FOR COST OF CREATION. The Harris
- 27 County Improvement District No. 11 may reimburse the cost of

- 1 creating the district from assessments or other revenue created by
- 2 the district or consolidated district under Section 3878.251,
- 3 Special District Local Laws Code, as added by this Act.
- 4 SECTION 4. LEGISLATIVE FINDINGS. The legislature finds
- 5 that:
- 6 (1) proper and legal notice of the intention to
- 7 introduce this Act, setting forth the general substance of this
- 8 Act, has been published as provided by law, and the notice and a
- 9 copy of this Act have been furnished to all persons, agencies,
- 10 officials, or entities to which they are required to be furnished by
- 11 the constitution and laws of this state, including the governor,
- 12 who has submitted the notice and Act to the Texas Commission on
- 13 Environmental Quality;
- 14 (2) the Texas Commission on Environmental Quality has
- 15 filed its recommendations relating to this Act with the governor,

- 18 (3) the general law relating to consent by political
- 19 subdivisions to the creation of districts with conservation,
- 20 reclamation, and road powers and the inclusion of land in those
- 21 districts has been complied with; and
- 22 (4) all requirements of the constitution and laws of
- 23 this state and the rules and procedures of the legislature with
- 24 respect to the notice, introduction, and passage of this Act have
- 25 been fulfilled and accomplished.
- 26 SECTION 5. EFFECTIVE DATE. This Act takes effect
- 27 immediately if it receives a vote of two-thirds of all the members

- 1 elected to each house, as provided by Section 39, Article III, Texas
- 2 Constitution. If this Act does not receive the vote necessary for
- 3 immediate effect, this Act takes effect September 1, 2009.
