## A BILL TO BE ENTITLED

2	relating to the creation of the North Oak Cliff Municipal

5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle C, Title 4, Special District Local Laws
7	Code, is amended by adding Chapter 3884 to read as follows:
8	CHAPTER 3884. NORTH OAK CLIFF MUNICIPAL MANAGEMENT DISTRICT
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 3884.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the district's board of directors.
12	(2) "City" means the City of Dallas.
13	(3) "District" means the North Oak Cliff Municipal
14	Management District.
15	(4) "Improvement project" means a project authorized
16	by Section 3884.102:
17	(A) inside the boundaries of the district; and
18	(B) in areas outside but adjacent to the
19	boundaries of the district if the project is for the purpose of
20	extending public infrastructure improvements beyond the district's
21	boundaries to a logical terminus.
22	Sec. 3884.002. CREATION AND NATURE OF DISTRICT. The
23	district is a special district created under Section 59, Article
24	XVI, Texas Constitution.

- 1 Sec. 3884.003. PURPOSE; LEGISLATIVE FINDINGS. (a) The
- 2 creation of the district is essential to accomplish the purposes of
- 3 Sections 52 and 52-a, Article III, and Section 59, Article XVI,
- 4 Texas Constitution, and other public purposes stated in this
- 5 chapter. By creating the district and in authorizing the city and
- 6 other political subdivisions to contract with the district, the
- 7 legislature has established a program to accomplish the public
- 8 purposes set out in Section 52-a, Article III, Texas Constitution.
- 9 (b) The creation of the district is necessary to promote,
- 10 develop, encourage, and maintain employment, commerce,
- 11 transportation, housing, tourism, recreation, the arts,
- 12 entertainment, economic development, safety, the public welfare in
- 13 the district, and educational scholarships for college-bound
- 14 students residing in or out of the district.
- 15 <u>(c) The district is created to supplement and not to</u>
- 16 <u>supplant city services provided in the district.</u>
- 17 Sec. 3884.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a)
- 18 The district is created to serve a public use and benefit.
- 19 (b) All land and other property included in the district
- 20 will benefit from the improvements and services to be provided by
- 21 the district under powers conferred by Sections 52 and 52-a,
- 22 Article III, and Section 59, Article XVI, Texas Constitution, and
- 23 other powers granted under this chapter.
- (c) The creation of the district is in the public interest
- 25 and is essential to further the public purposes of:
- 26 (1) developing and diversifying the economy of the
- 27 state;

- 1 Sec. 3884.005. DISTRICT TERRITORY. (a) The district is
- 2 composed of the territory described by Section 2 of the Act creating
- 3 this chapter, as that territory may have been modified under
- 4 Section 3884.106.
- 5 (b) A mistake in the field notes of the district contained
- 6 in Section 2 of the Act creating this chapter or in copying the
- 7 <u>field notes in the legislative process does not in any way affect:</u>
- 8 <u>(1) the district's organization, existence, or</u>
- 9 validity;
- 10 (2) the district's right to contract, including the
- 11 right to issue any type of bond or other obligation for a purpose
- 12 for which the district is created;
- 13 (3) the district's right to impose or collect an
- 14 assessment, tax, or any other revenue; or
- 15 (4) the legality or operation of the board.
- 16 Sec. 3884.006. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES.
- 17 (a) All or any part of the area of the district is eligible to be
- 18 included in:
- 19 (1) a tax increment reinvestment zone created by the
- 20 city under Chapter 311, Tax Code;
- 21 (2) a tax abatement reinvestment zone created by the
- 22 city under <u>Chapter 312</u>, <u>Tax Code</u>; or
- 23 (3) an enterprise zone created by the city under
- 24 Chapter 2303, Government Code.
- 25 (b) If the city creates a tax increment reinvestment zone
- 26 described by Subsection (a), the city and the board of directors of
- 27 the zone, by contract with the district, may grant money deposited

- 1 in the tax increment fund to the district to be used by the district
- 2 for the purposes permitted for money granted to a corporation under
- 3 Section 380.002(b), Local Government Code, including the right to
- 4 pledge the money as security for any bonds issued by the district
- 5 for an improvement project. A project may not receive public funds
- 6 under Section 380.002(b), Local Government Code, unless the project
- 7 has been approved by the governing body of the city by the adoption
- 8 of a resolution.
- 9 (c) A tax increment reinvestment zone created by the city in
- 10 the district is not subject to the limitations provided by Section
- 11 311.006(b), Tax Code.
- 12 [Sections 3884.007-3884.050 reserved for expansion]
- SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 3884.051. GOVERNING BODY; TERMS. (a) The district is
- 15 governed by a board of nine directors composed of:
- 16 (1) six directors appointed by the governing body of
- 17 the city under Subsections (b) and (c);
- 18 (2) one assistant city manager of the city, appointed
- 19 by the city manager;
- 20 (3) the chief financial officer of the city; and
- 21 (4) the economic director of the city.
- (b) Before the term of each director expires as provided by
- 23 Subsection (d), the owner or owners of a majority of the appraised
- 24 value of the real property in the district, or the majority of the
- 25 record owners of real property in the district subject to taxation,
- 26 may submit a petition to the governing body of the city requesting
- 27 that the governing body appoint as successor directors the persons

- 1 named in the petition. If the persons named in the petition meet
- 2 the qualifications prescribed by Sections 3884.052 and 3884.053,
- 3 the governing body may appoint those persons as successor
- 4 directors.
- 5 (c) If a petition is not submitted under Subsection (b), the
- 6 governing body of the city shall appoint as successor directors
- 7 persons who meet the qualifications prescribed by Sections 3884.052
- 8 and 3884.053.
- 9 (d) Directors serve staggered terms of four years, with four
- 10 or five directors' terms expiring July 1 of each odd-numbered year.
- 11 Sec. 3884.052. APPOINTMENT OF DIRECTORS; BOARD MEETINGS.
- 12 (a) Directors appointed by the governing body of the city must meet
- 13 at least one of the qualifications prescribed by Section 3884.053.
- 14 (b) A person may not be appointed to the board by the
- 15 governing body of the city if the appointment of that person would
- 16 <u>result in fewer than:</u>
- 17 (1) four of the directors being residents of the city
- 18 and meeting the qualifications prescribed by Section
- 19 3884.053(a)(2), (3), (4), or (5); and
- 20 (2) two of the directors meeting the qualifications
- 21 prescribed by Section 3884.053(a)(1).
- (c) The governing body of the city may not appoint a person
- 23 as a director if the appointment will result in more than four
- 24 persons serving on the board at any time who are seeking financial
- 25 assistance or reimbursement from the district for capital
- 26 improvements in the district.
- 27 (d) The governing body of the city may remove a member of the

- 1 board with or without cause at any time by a majority vote.
- 2 (e) The board shall hold meetings at a place accessible to
- 3 the public. The board shall file a copy of the notice of a meeting
- 4 with the city's secretary. The city's secretary shall post the
- 5 notice at Dallas City Hall.
- 6 (f) The board may not create an executive committee to
- 7 exercise the powers of the board.
- 8 (g) If an office described in Section 3884.051(a) is
- 9 renamed, changed, or abolished, the governing body of the city may
- 10 appoint another city officer or employee who performs duties
- 11 comparable to those performed by the officer described by that
- 12 subsection.
- 13 Sec. 3884.053. QUALIFICATIONS OF DIRECTORS APPOINTED BY
- 14 CITY. (a) To be qualified to serve as a director appointed by the
- 15 governing body of the city, a person must be at least 18 years old
- 16 and must be:
- 17 (1) a resident of the district who is also a registered
- 18 voter of the district or a registered voter who lives within a
- 19 two-mile radius of the district;
- 20 (2) an owner of property in the district;
- 21 (3) an owner of stock, whether beneficial or
- 22 otherwise, of a corporate owner of property in the district;
- 23 (4) an owner of a beneficial interest in a trust that
- 24 owns property in the district; or
- 25 (5) an agent, employee, or tenant of a person covered
- 26 by Subdivision (2), (3), or (4).
- (b) Section 49.052, Water Code, does not apply to the

- 1 <u>district.</u>
- 2 Sec. 3884.054. VACANCY. The governing body of the city
- 3 shall fill a vacancy on the board by appointing a person who meets
- 4 the qualifications prescribed by Section 3884.051(a) or 3884.053 to
- 5 serve for the remainder of the unexpired term.
- 6 Sec. 3884.055. DIRECTOR'S OATH OR AFFIRMATION. A
- 7 director's oath or affirmation of office shall be filed with the
- 8 district and the district shall retain the oath or affirmation in
- 9 the district records. A copy of each director's oath or affirmation
- 10 of office shall be filed with the city's secretary.
- 11 Sec. 3884.056. OFFICERS. The board shall elect from among
- 12 the directors a chair, a vice chair, and a secretary. The offices
- 13 of chair and secretary may not be held by the same person
- 14 concurrently.
- 15 Sec. 3884.057. COMPENSATION; EXPENSES; LIABILITY INSURANCE
- 16 FOR DIRECTORS. (a) The district may compensate each director in an
- 17 amount not to exceed \$50 for each board meeting. The total amount
- 18 of compensation for each director in one year may not exceed \$2,000.
- 19 (b) Directors are entitled to reimbursement for necessary
- 20 and reasonable expenses incurred in carrying out the duties and
- 21 <u>responsibilities of the board.</u>
- (c) The district may obtain and pay for comprehensive
- 23 general liability insurance coverage from a commercial insurance
- 24 company or other source that protects and insures a director
- 25 against personal liability and from any and all claims relating to:
- 26 (1) actions taken by the director in the director's
- 27 capacity as a member of the board;

- 1 (2) actions and activities taken by the district; or
- 2 (3) the actions of others acting on behalf of the
- 3 district.
- 4 Sec. 3884.058. CONFLICTS OF INTEREST. (a) A director,
- 5 including a director who qualifies under Section 3884.053(a)(2),
- 6 (3), (4), or (5), may participate in all board votes and decisions
- 7 if the director complies with the requirements of Subsection (b).
- 8 (b) A director shall comply with Section 171.004, Local
- 9 Government Code, including the disclosure and abstention
- 10 requirements of that section. A director must file a copy of the
- 11 director's disclosure affidavit required by Section 171.004, Local
- 12 Government Code, with the city's secretary before participating in
- 13 a board discussion or vote.
- Sec. 3884.059. <u>INITIAL DIRECTORS</u>. (a) The initial board
- 15 consists of the following directors:
- 16 (1) Place 1: a director who qualifies under Section
- 17 3884.053(a)(2), (3), (4), or (5), appointed by the governing body
- 18 of the city;
- 19 (2) Place 2: a director who qualifies under Section
- 20 <u>3884.053(a)(2), (3), (4), or (5), appointed by the governing body</u>
- 21 of the city;
- 22 (3) Place 3: a director who qualifies under Section
- 23 3884.053(a)(2), (3), (4), or (5), appointed by the governing body
- 24 of the city;
- 25 (4) Place 4: a director who qualifies under Section
- 26 3884.053(a)(2), (3), (4), or (5), appointed by the governing body
- 27 of the city;

1	(5) Place 5: a director who qualifies under Section
2	3884.053(a)(1), appointed by the governing body of the city;
3	(6) Place 6: a director who qualifies under Section
4	3884.053(a)(1), appointed by the governing body of the city;
5	(7) Place 7: a City of Dallas assistant city manager,
6	appointed by the Dallas city manager;
7	(8) Place 8: the City of Dallas chief financial
8	officer; and
9	(9) Place 9: the director of the City of Dallas
10	Office of Economic Development.
11	(b) Of the initial directors, the terms of directors
12	appointed for places 1, 2, 3, and 4 expire July 1, 2011, and the
13	terms of directors appointed for places 5, 6, 7, 8, and 9 expire
14	July 1, 2013.
15	(c) This section expires September 1, 2013.
16	[Sections 3884.060-3884.100 reserved for expansion]
17	SUBCHAPTER C. POWERS AND DUTIES
18	Sec. 3884.101. GENERAL POWERS AND DUTIES. The district has
19	the powers and duties provided by this chapter and by:
20	(1) the general laws relating to conservation and
21	reclamation districts created under Section 59, Article XVI, Texas
22	Constitution, including Chapters 49 and 54, Water Code;
23	(2) Chapter 441, Transportation Code, except that:
24	(A) the district may exercise any power granted
25	by this chapter without regard to any provision or requirement of or
26	procedure prescribed by Chapter 441, Transportation Code; and
27	(B) the district may not build or operate a toll

1	<pre>road;</pre>
2	(3) Subchapter A, Chapter 372, Local Government Code,
3	in the same manner as a municipality or a county;
4	(4) Chapter 1371, Government Code;
5	(5) Chapter 375, Local Government Code; and
6	(6) Chapter 311, Tax Code.
7	Sec. 3884.102. IMPROVEMENT PROJECTS. (a) The district may
8	provide, or it may enter into contracts with a governmental or
9	private entity to provide, the following types of improvement
10	projects located in the district or activities in support of or
11	<pre>incidental to those projects:</pre>
12	(1) a supply and distribution facility or system to
13	provide potable and nonpotable water to the residents and
14	businesses of the district, including a wastewater collection
15	<pre>facility;</pre>
16	(2) a paved, macadamized, or graveled road or street,
17	inside and outside the district, to the full extent authorized by
18	Section 52, Article III, Texas Constitution;
19	(3) the planning, design, construction, improvement,
20	and maintenance of:
21	(A) landscaping;
22	(B) highway right-of-way or transit corridor
23	beautification and improvement;
24	(C) lighting, banners, and signs;
25	(D) a street or sidewalk;
26	(E) a hiking and cycling path or trail;
27	(F) a pedestrian walkway, skywalk, crosswalk, or

1	<pre>tunnel;</pre>
2	(G) a park, lake, garden, recreational facility,
3	community activities center, dock, wharf, sports facility, open
4	space, scenic area, or related exhibit or preserve;
5	(H) a fountain, plaza, or pedestrian mall; or
6	(I) a drainage or storm-water detention
7	<pre>improvement;</pre>
8	(4) protection and improvement of the quality of storm
9	water that flows through the district;
10	(5) the planning, design, construction, improvement,
11	<pre>maintenance, and operation of:</pre>
12	(A) a water or sewer facility; or
13	(B) an off-street parking facility or heliport;
14	(6) the planning and acquisition of:
15	(A) public art and sculpture and related exhibits
16	and facilities; or
17	(B) an educational facility, and a cultural
18	exhibit or facility;
19	(7) the planning, design, construction, acquisition,
20	lease, rental, improvement, maintenance, installation, and
21	management of and provision of furnishings for a facility for:
22	(A) a conference, convention, or exhibition;
23	(B) a manufacturer, consumer, or trade show;
24	(C) a civic, community, or institutional event;
25	<u>or</u>
26	(D) an exhibit, display, attraction, special
27	event, or seasonal or cultural celebration or holiday:

1	(8) the removal, razing, demolition, or clearing of
2	land or improvements in connection with improvement projects;
3	(9) the acquisition and improvement of land or other
4	property for the mitigation of the environmental effects of an
5	improvement project if those costs are incurred in accordance with
6	a development agreement and reimbursement of those costs is
7	conditioned on the completion of substantial vertical development,
8	or the costs are related to a transit or mobility project;
9	(10) the acquisition of property or an interest in
10	property in connection with one or more authorized improvement
11	projects, including a project authorized by Subchapter A, Chapter
12	372, Local Government Code;
13	(11) a special or supplemental service for the
14	improvement and promotion of the district or an area adjacent to the
15	district or for the protection of public health and safety in or
16	adjacent to the district, including:
17	(A) advertising;
18	(B) promotion;
19	(C) tourism;
20	(D) health and sanitation;
21	(E) public safety;
22	(F) security;
23	(G) fire protection or emergency medical
24	services;
25	(H) business recruitment;
26	(I) elimination of traffic congestion, including
27	by use of rail services;

- 1 (J) recreational, educational, or cultural
- 2 improvements, enhancements, and services; and
- 3 (K) creation and financing of a higher education
- 4 scholarship fund for students attending Mountain View College or
- 5 the University of North Texas (Dallas Campus); or
- 6 (12) any similar public improvement, facility, or
- 7 <u>service</u>.
- 8 (b) The district may not undertake an improvement project
- 9 under this section unless the board determines the project to be
- 10 necessary to accomplish a public purpose of the district and has
- 11 received the approval of the city under Section 3884.160.
- 12 (c) An improvement project must comply with any applicable
- 13 codes and ordinances of the city.
- 14 (d) The district may not provide, conduct, or authorize an
- improvement project on the city streets, highways, rights-of-way,
- 16 or easements without the consent of the governing body of the city.
- 17 (e) Subject to an agreement between the district and the
- 18 city, the city may:
- 19 (1) by ordinance, order, or resolution require that
- 20 title to all or any portion of an improvement project vest in the
- 21 city; or
- 22 (2) unless prohibited by Subsection (h), by ordinance,
- 23 order, resolution, or other directive, authorize the district to
- 24 own, encumber, maintain, and operate an improvement project,
- 25 subject to the right of the city to order a conveyance of the
- 26 improvement project to the city on a date determined by the city.
- 27 (f) The district shall immediately comply with any city

- 1 ordinance, order, or resolution adopted under Subsection (e).
- 2 (g) For the purposes of this section, planning, design,
- 3 construction, improvement, and maintenance of a lake includes work
- 4 done for drainage, reclamation, or recreation.
- 5 (h) Waterworks and sanitary sewer improvements may be
- 6 undertaken by the district inside or outside the boundaries of the
- 7 <u>district</u>, <u>subject to the following conditions:</u>
- 8 <u>(1) the city shall request that waterworks or sanitary</u>
- 9 sewer improvements be funded by the district;
- 10 (2) the city shall construct, own, operate, and
- 11 maintain the improvements; and
- 12 (3) the district shall comply with Sections 3884.152,
- 13 3884.157, and 3884.160 as a condition for the district to fund the
- 14 improvements.
- 15 <u>Sec. 3884.103. GENERAL POWERS REGARDING CONTRACTS.</u> (a)
- 16 The district may:
- 17 <u>(1) contract with any person to accomplish any</u>
- 18 district purpose, including a contract for:
- 19 <u>(A) the payment, repayment, or reimbursement of</u>
- 20 costs incurred by that person on behalf of the district, including
- 21 all or part of the costs of any improvement project and interest on
- 22 the reimbursed cost; or
- (B) the use, occupancy, lease, rental,
- 24 operation, maintenance, or management of all or part of a proposed
- 25 or existing improvement project; and
- 26 (2) apply for and contract with any person to receive,
- 27 administer, and perform a duty or obligation of the district under a

- 1 federal, state, local, or private gift, grant, loan, conveyance,
- 2 transfer, bequest, or other financial assistance arrangement
- 3 relating to the investigation, planning, analysis, study, design,
- 4 acquisition, construction, improvement, completion,
- 5 implementation, or operation by the district or others of a
- 6 proposed or existing improvement project.
- 7 (b) A contract the district enters into to carry out a
- 8 purpose of this chapter may be on any terms and for any period the
- 9 board determines, including a negotiable or nonnegotiable note or
- 10 warrant payable to the city, Dallas County, or any other person.
- 11 (c) Any person may contract with the district to carry out
- 12 the purposes of this chapter without further statutory or other
- 13 authorization.
- 14 (d) The district must follow Resolution 08-2826, adopted by
- 15 the city on October 22, 2008, for construction, procurement, and
- 16 professional services contracts related to the use of historically
- 17 underutilized businesses and minority contracting in the
- 18 implementation of its district plan.
- 19 Sec. 3884.104. RULES; ENFORCEMENT. (a) The district may
- 20 adopt rules:
- 21 (1) to administer or operate the district;
- (2) for the use, enjoyment, availability, protection,
- 23 security, and maintenance of the district's property and
- 24 facilities; or
- 25 (3) to provide for public safety and security in the
- 26 district.
- 27 (b) The district may enforce its rules by injunctive relief.

- 1 (c) To the extent a district rule conflicts with a city
- 2 rule, order, or regulation, the city rule, order, or regulation
- 3 controls.
- 4 (d) The district shall provide the city with written notice
- 5 not later than the 30th day before the date of a meeting at which the
- 6 board will adopt rules. The district may not adopt a rule affecting
- 7 the use of a municipally owned asset, such as a public park, street,
- 8 sidewalk, transit facility, or public right-of-way, unless the
- 9 governing body of the city has approved the rule by ordinance,
- 10 order, or resolution.
- 11 Sec. 3884.105. NAME CHANGE. The board by resolution may
- 12 change the district's name. The board shall give written notice of
- 13 the change to the city.
- 14 Sec. 3884.106. ADDING OR REMOVING TERRITORY. The board may
- 15 add or remove territory under Subchapter J, Chapter 49, Water Code,
- and Section 54.016, Water Code, except that:
- 17 (1) the addition or removal of the territory must be
- 18 approved by:
- 19 (A) the governing body of the city by ordinance,
- 20 order, or resolution; and
- 21 (B) the owners of the territory being added or
- 22 <u>removed;</u>
- (2) a reference to a tax in Subchapter J, Chapter 49,
- 24 Water Code, or Section 54.016, Water Code, means an ad valorem tax;
- 25 and
- 26 (3) territory may not be removed from the district if
- 27 bonds or other obligations of the district payable wholly or partly

- 1 from ad valorem taxes or assessments imposed or assessed on the
- 2 territory are outstanding.
- 3 Sec. 3884.107. ECONOMIC DEVELOPMENT. (a) The district may
- 4 create economic development and other programs under Section 52-a,
- 5 Article III, Texas Constitution, and may impose and collect ad
- 6 valorem taxes for those purposes. The district has the economic
- 7 development powers that Chapter 380, Local Government Code,
- 8 provides to a municipality with a population of more than 100,000.
- 9 Each economic development program and each project that will
- 10 receive public funds under an economic development program must be
- 11 approved by the governing body of the city by ordinance, order, or
- 12 resolution.
- 13 (b) The district shall provide the city written notice not
- 14 later than the 30th day before the date of a meeting at which the
- 15 board will adopt terms of an economic development program. The
- 16 <u>district may not adopt an economic development program or</u>
- 17 improvement project to be funded under an economic development
- 18 program unless the governing body of the city has approved the
- 19 program or improvement project by ordinance, order, or resolution.
