A BILL TO BE ENTITLED 1 AN ACT 2 relating to the creation of the Tornillo Management District; providing authority to impose a tax and issue bonds; granting the 3 power of eminent domain. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 6 SECTION 1. Subtitle C, Title 4, Special District Local Laws 7 Code, is amended by adding Chapter 3845 to read as follows: CHAPTER 3845. TORNILLO MANAGEMENT DISTRICT 8 9 SUBCHAPTER A. GENERAL PROVISIONS Sec. 3845.001. DEFINITIONS. In this chapter: 10 11 (1) "Board" means the district's board of directors. 12 (2) "Director" means a board member. (3) "District" means the Tornillo Management 13 14 District. Sec. 3845.002. NATURE OF DISTRICT. The district is a 15 16 special district created under Sections 52 and 52-a, Article III, and Section 59, Article XVI, Texas Constitution. 17 18 Sec. 3845.003. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a) The district is created to serve a public purpose and benefit. 19 (b) All land and other property included in the district 20 21 will benefit from the improvements and services to be provided by the district under powers conferred by Sections 52 and 52-a, 22 23 Article III, and Section 59, Article XVI, Texas Constitution, and other powers granted under this chapter. 24

1 (c) The district is created to accomplish the purposes of a 2 municipal management district as provided by general law and Sections 52 and 52-a, Article III, and Section 59, Article XVI, 3 4 Texas Constitution. 5 (d) The creation of the district is in the public interest and is essential to: 6 7 (1) further the public purposes of developing and 8 diversifying the economy of the state; 9 (2) eliminate unemployment and underemployment; and 10 (3) develop or expand transportation and commerce. 11 (e) The district will: 12 (1) promote the health, safety, and general welfare of residents, employers, potential employees, employees, visitors, 13 14 and consumers in the district, and of the public; 15 (2) provide needed funding for the district to preserve, maintain, and enhance the economic health and vitality of 16 17 the district territory as a community and business center; and (3) promote the health, safety, welfare, and enjoyment 18 19 of the public by providing pedestrian ways and by landscaping and developing certain areas in the district, which are necessary for 20 the restoration, preservation, and enhancement of scenic beauty. 21 22 (f) Pedestrian ways along or across a street, whether at grade or above or below the surface, and street lighting, street 23 24 landscaping, parking, and street art objects are parts of and necessary components of a street and are considered to be a street 25 26 or road improvement. 27 (g) The district will not act as the agent or

instrumentality of any private interest even though the district 1 will benefit many private interests as well as the public. 2 Sec. 3845.004. INITIAL DISTRICT TERRITORY. (a) 3 The district is initially composed of the territory described by 4 5 Section 2 of the Act creating this chapter. 6 (b) The boundaries and field notes contained in Section 2 of 7 the Act creating this chapter form a closure. A mistake made in the field notes or in copying the field notes in the legislative 8 process does not affect the district's: 9 (1) organization, existence, or validity; 10 (2) right to issue any type of bond for the purposes 11 12 for which the district is created or to pay the principal of and interest on a bond; 13 14 (3) right to impose a tax; or 15 (4) legality or operation. [Sections 3845.005-3845.050 reserved for expansion] 16 17 SUBCHAPTER B. BOARD OF DIRECTORS Sec. 3845.051. GOVERNING BODY; TERMS. (a) The district is 18 19 governed by a board of five elected directors. (b) Except as provided by Section 3845.053, directors serve 20 staggered four-year terms. 21 (c) On the uniform election date in May of each 22 even-numbered year, the appropriate number of directors shall be 23 24 elected. Sec. 3845.052. QUALIFICATIONS. To be qualified to serve as 25 26 a director, a person must be: 27 at least 18 years old;

1	(2) a resident of the state; and
2	(3) an owner of real property subject to taxation in
3	the district or a qualified voter of the district.
4	Sec. 3845.053. INITIAL DIRECTORS. (a) On or after the
5	effective date of the Act creating this chapter, the owner or
6	owners of a majority of the assessed value of the real property in
7	the district may submit a petition to the Texas Commission on
8	Environmental Quality requesting that the commission appoint as
9	initial directors the five qualified persons named in the petition.
10	The commission shall appoint as initial directors the five persons
11	named in the petition.
12	(b) The initial directors appointed under Subsection (a)
13	shall draw lots to determine which two shall serve until the first
14	regularly scheduled election of directors under Section 3845.051
15	and which three shall serve until the second regularly scheduled
16	election of directors.

18	SUBCHAPTER C. POWERS AND DUTIES
19	Sec. 3845.101. GENERAL POWERS AND DUTIES. The district has
20	the powers and duties necessary to accomplish the purposes for
21	which the district is created.
22	Sec. 3845.102. MUNICIPAL MANAGEMENT DISTRICT POWERS AND
23	DUTIES. The district has the powers and duties provided by the
24	general law of this state, including Chapter 375, Local Government
25	Code, applicable to municipal management districts created under
26	Sections 52 and 52-a, Article III, and Section 59, Article XVI,
27	Texas Constitution.

1	Sec. 3845.103. NO EMINENT DOMAIN POWER. The district may
2	not exercise the power of eminent domain.
3	Sec. 3845.104. WATER AND WASTEWATER FACILITIES AND
4	SERVICES. (a) The district may not provide retail water or
5	wastewater services inside or outside the boundaries of the
6	district unless authorized by a resolution of the board of
7	directors of the El Paso County Tornillo Water Improvement District
8	that specifies the area that will receive the water services.
9	Notwithstanding any other law, the El Paso County Tornillo Water
10	Improvement District may not be required to provide retail water or
11	wastewater services to an area in which the district is authorized
12	to provide water services.
13	(b) The district may construct and maintain water or
14	wastewater facilities only according to standards established by
15	the El Paso County Tornillo Water Improvement District.
16	Sec. 3845.105. RAIL FACILITIES. The district may
17	construct, acquire, improve, maintain, and operate rail facilities
18	and improvements in aid of those facilities.
19	Sec. 3845.106. DEVELOPMENT CORPORATION POWERS. The
20	district may exercise the powers given to a corporation under
21	Chapter 505, Local Government Code, including the power to own,
22	operate, acquire, construct, lease, improve, and maintain the
23	projects described by that chapter.
24	[Sections 3845.107-3845.150 reserved for expansion]
25	SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
26	Sec. 3845.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The
27	district may issue, without an election, bonds and other

1	obligations secured by revenue or contract payments from any source
2	other than ad valorem taxation.
3	(b) The district must hold an election in the manner
4	provided by Chapters 49 and 54, Water Code, to obtain voter approval
5	before the district may impose an ad valorem tax or issue bonds
6	payable from ad valorem taxes.
7	(c) The district may not issue bonds payable from ad valorem
8	taxes to finance a road project unless the issuance is approved by a
9	vote of a two-thirds majority of the district voters voting at an
10	election held for that purpose.
11	Sec. 3845.152. OPERATION AND MAINTENANCE TAX. (a) If
12	authorized at an election held under Section 3845.151, the district
13	may impose an operation and maintenance tax on taxable property in
14	the district in accordance with Section 49.107, Water Code.
15	(b) The board shall determine the tax rate. The rate may not
16	exceed the rate approved at the election.
17	Sec. 3845.153. CONTRACT TAXES. (a) In accordance with
18	Section 49.108, Water Code, the district may make payments under a
19	contract from taxes other than operation and maintenance taxes
20	after the provisions of the contract have been approved by a
21	majority of the district voters voting at an election held for that
22	purpose.
23	(b) A contract approved by the district voters may contain a
24	provision stating that the contract may be modified or amended by
25	the board without further voter approval.
26	Sec. 3845.154. TAXES FOR WATER, WASTEWATER, AND DRAINAGE
27	PURPOSES. Taxes the district imposes for water, wastewater, and

1 drainage facility construction and maintenance purposes are for the 2 particular benefit of the area inside the district, do not generally or directly benefit the area inside the El Paso County 3 Tornillo Water Improvement District as a whole, and do not 4 5 duplicate a tax imposed by the El Paso County Tornillo Water Improvement District. 6 Sec. 3845.155. HOTEL OCCUPANCY TAX. The district may 7 8 impose a hotel occupancy tax in the manner provided by Section 351.002, Tax Code. A tax imposed under this section may not exceed 9 10 the maximum rate provided by Section 351.003(a), Tax Code. Sec. 3845.156. SALES AND USE TAX. (a) The district may 11 12 impose a sales and use tax if authorized by a majority of the voters of the district voting at an election held for that purpose. 13 Revenue from the tax may be used for any purpose for which ad 14 15 valorem tax revenue of the district may be used. (b) The district may not adopt a sales and use tax at a rate 16 17 greater than two percent, and the rate of the tax when combined with the rates of all other sales and use taxes imposed in the district 18 19 may not exceed the total combined sales and use tax rate imposed in the City of El Paso. 20 21 (c) Chapter 321, Tax Code, applies to the imposition, 22 computation, administration, enforcement, and collection of the 23 sales and use tax imposed by this section except to the extent it is 24 inconsistent with this chapter. Sec. 3845.157. AUTHORITY TO TAX. The district may impose 25 26 taxes only inside the district's boundaries. 27 [Sections 3845.158-3845.200 reserved for expansion]

1	SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS
2	Sec. 3845.201. AUTHORITY TO ISSUE BONDS AND OTHER
3	OBLIGATIONS. The district may issue bonds or other obligations
4	payable wholly or partly from ad valorem taxes, impact fees,
5	revenue, contract payments, grants, hotel occupancy taxes, sales
6	and use taxes, revenue from economic development agreements under
7	Chapter 381, Local Government Code, or other district money, or any
8	combination of those sources, to pay for an authorized district
9	purpose.
10	Sec. 3845.202. TAXES FOR BONDS. (a) At the time the
11	district issues bonds payable wholly or partly from ad valorem
12	taxes, the board shall provide for the annual imposition of an ad
13	valorem tax, without limit as to rate or amount, as required by
14	Section 54.601, Water Code.
15	(b) The board shall impose the tax annually while all or
16	part of the bonds are outstanding. Sections 54.601 and 54.602,
17	Water Code, govern the amount and rate of the tax.
18	Sec. 3845.203. BONDS FOR ROAD PROJECTS. At the time of
19	issuance, the total principal amount of bonds or other obligations
20	issued or incurred to finance road projects may not exceed
21	one-fourth of the assessed value of the real property in the
22	district.
23	Sec. 3845.204. FINANCIAL RESPONSIBILITY OF EL PASO COUNTY
24	TORNILLO WATER IMPROVEMENT DISTRICT. This chapter may not be
25	construed as creating an obligation of the El Paso County Tornillo
26	Water Improvement District for a debt incurred by the district.
27	SECTION 2. The Tornillo Management District initially

20 SECTION 3. (a) The legal notice of the intention to 21 introduce this Act, setting forth the general substance of this 22 Act, has been published as provided by law, and the notice and a 23 copy of this Act have been furnished to all persons, agencies, 24 officials, or entities to which they are required to be furnished 25 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 26 Government Code.

(b) The governor, one of the required recipients, has

submitted the notice and Act to the Texas Commission on
 Environmental Quality.

3 (c) The Texas Commission on Environmental Quality has filed 4 its recommendations relating to this Act with the governor, the 5 lieutenant governor, and the speaker of the house of 6 representatives within the required time.

7 (d) All requirements of the constitution and laws of this 8 state and the rules and procedures of the legislature with respect 9 to the notice, introduction, and passage of this Act are fulfilled 10 and accomplished.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2009.
