- 23 Code, does not apply to an election to:
- 24 (1) confirm the district's creation;

3	Sec. 8368.005. CONSENT OF MUNICIPALITY REQUIRED. The
4	temporary directors may not hold an election under Section 8368.003
5	until each municipality in whose corporate limits or
6	extraterritorial jurisdiction the district is located has
7	consented by ordinance or resolution to the inclusion of land in the
8	<u>district.</u>
9	Sec. 8368.006. TERRITORY ADDED. (a) The territory
10	described by Section 2 of the Act creating this chapter is added to
11	the district's territory as of the effective date of this section.
12	(b) The boundaries and field notes contained in Section 2 of
13	the Act creating this chapter form a closure. A mistake made in the
14	field notes or in copying the field notes in the legislative process
15	<pre>does not affect the district's:</pre>
16	(1) organization, existence, or validity;
17	(2) right to issue any type of bond for the purposes
18	for which the district is created or to pay the principal of and
19	<u>interest on a bond;</u>
20	(3) right to impose a tax; or
21	(4) legality or operation.

1 Sec. 8368.052. TEMPORARY DIRECTORS. (a) The temporary board consists of: 2 3 (1) Benjamin B. Tolson; (2) Jordan R. Smith; 4 (3) Shad Schmid; 5 (4) Ryan N. Stevens; and 6 7 (5) Janet Cobbel. 8 (b) Temporary directors serve until the earlier of: (1) the date permanent directors are elected under 9 10 Section 8368.003; or (2) the fourth anniversary of the effective date of 11 12 the Act creating this chapter. (c) If permanent directors have not been elected under 13 14 Section 8368.003 and the terms of the temporary directors have 15 expired, successor temporary directors shall be appointed or reappointed as provided by Subsection (d) to serve terms that 16 17 expire on the earlier of: 18 (1) the date permanent directors are elected under 19 Section 8368.003; or 20 (2) the fourth anniversary of the date of the 21 appointment or reappointment. (d) If Subsection (c) applies, the owner or owners of a 22 majority of the assessed value of the real property in the district 23 24 may submit a petition to the Texas Commission on Environmental Quality requesting that the commission appoint as successor 25 26 temporary directors the five persons named in the petition. - 4 Sec. 8368.101. MUNICIPAL UTILITY DISTRICT POWERS AND
- 5 DUTIES. The district has the powers and duties provided by the
- 6 general law of this state, including Chapters 49 and 54, Water Code,
- 7 applicable to municipal utility districts created under Section 59,
- 8 Article XVI, Texas Constitution.
- 9 Sec. 8368.102. AUTHORITY FOR ROAD PROJECTS. Under Section
- 10 52, Article III, Texas Constitution, the district may design,
- 11 acquire, construct, finance, issue bonds for, improve, operate,
- 12 maintain, and convey to this state, a county, or a municipality for
- 13 operation and maintenance macadamized, graveled, or paved roads,
- 14 including bridges, storm drainage, and other improvements or

- Sec. 8368.103. ROAD STANDARDS AND REQUIREMENTS. (a) A road
- 17 project must meet all applicable construction standards, zoning and
- 18 subdivision requirements, and regulations of each municipality in
- 19 whose corporate limits or extraterritorial jurisdiction the road
- 20 project is located.
- 21 (b) If a road project is not located in the corporate limits
- 22 or extraterritorial jurisdiction of a municipality, the road
- 23 project must meet all applicable construction standards,
- 24 subdivision requirements, and regulations of each county in which
- 25 the road project is located.
- 26 (c) If a municipality or county will maintain and operate
- 27 the road, the municipality or county must approve the plans and

- 1 specifications of the road project.
- 2 (d) If the state will maintain and operate the road, the
- 3 Texas Transportation Commission must approve the plans and
- 4 specifications of the road project.
- 5 Sec. 8368.104. DIVISION OF DISTRICT. (a) The district may
- 6 be divided into two or more new districts only if the district:
- 7 (1) has no outstanding bonded debt; and
- 8 (2) is not imposing ad valorem taxes or assessments.
- 9 (b) This chapter applies to any new district created by the
- 10 division of the district, and a new district has all the powers and
- 11 duties of the district, including the power to divide in accordance
- 12 with this section.
- 13 <u>(c) Any new district created by the division of the district</u>
- 14 may not, at the time the new district is created, contain any land

LIMITATION ON USE OF EMINENT DOMAIN. The 22 district may not exercise the power of eminent domain outside the 23 24 district to acquire a site or easement for: 25 (1) a road project authorized by Section 8368.102; or 26 (2) a recreational facility as defined by Section 27 49.462, Water Code.

(a) The district may not issue bonds payable from ad valorem taxes to finance a road 9 10 project unless the issuance is approved by a vote of a two-thirds majority of the district voters voting at an election held for that 11 12 purpose. (b) At the time of issuance, the total principal amount of 13 14 bonds or other obligations issued or incurred to finance road 15 projects and payable from ad valorem taxes may not exceed one-fourth of the assessed value of the real property in the 16 17 district.
