chapter. By creating the district and in authorizing the City of			
Houston, Harris County, and other political subdivisions to			
contract with the district, the legislature has established a

- 19 Article III, and Section 59, Article XVI, Texas Constitution, and
- 20 other powers granted under this chapter.
- 21 <u>(c)</u> The creation of the district is in the public interest

- 24 diversifying the economy of the state;

- 17 SUBCHAPTER F. TAXES FOR CERTAIN DEFINED AREAS AND DESIGNATED

- 19 Sec. 3880.251. AUTHORITY TO ESTABLISH DEFINED AREAS OR
- 20 DESIGNATED PROPERTY. The district may define areas or designate
- 21 certain property of the district to pay for improvements,
- 22 facilities, or services that primarily benefit that area or
- 23 property and do not generally and directly benefit the district as a

- Sec. 3880.252. PROCEDURE FOR ELECTION. (a) Before the
