9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 8345.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the district's board of directors.
12	(2) "Director" means a board member.
13	(3) "District" means the South Fork Ranch Municipal
14	Utility District.
15	Sec. 8345.002. NATURE OF DISTRICT. The district is a
16	municipal utility district created under Section 59, Article XVI,
17	Texas Constitution.
18	Sec. 8345.003. CONFIRMATION AND DIRECTORS' ELECTION
19	REQUIRED. The temporary directors shall hold an election to
20	confirm the creation of the district and to elect five permanent

FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a) 5 The district is created to serve a public purpose and benefit. 6 (b) The district is created to accomplish the purposes of: 7 (1) a municipal utility district as provided by general law and Section 59, Article XVI, Texas Constitution; and 8 (2) Section 52, Article III, Texas Constitution, that 9 10 relate to the construction, acquisition, or improvement of macadamized, graveled, or paved roads described by Section 54.234, 11 12 Water Code, or improvements, including storm drainage, in aid of 13 those roads. Sec. 8345.006. INITIAL DISTRICT TERRITORY. (a) 14 The 15 district is initially composed of the territory described by Section 2 of the Act creating this chapter. 16 17 (b) The boundaries and field notes contained in Section 2 of the Act creating this chapter form a closure. A mistake made in the 18 19 field notes or in copying the field notes in the legislative process does not affect the district's: 20 21 (1) organization, existence, or validity; 22 (2) right to issue any type of bond for the purposes for which the district is created or to pay the principal of and 23 24 interest on a bond; 25 (3) right to impose a tax; or 26 (4) legality or operation. POWERS AND DUTIES Sec. 8345.101. GENERAL POWERS AND DUTIES. The district has 9 10 the powers and duties necessary to accomplish the purposes for which the district is created. 11 12 Sec. 8345.102. MUNICIPAL UTILITY DISTRICT POWERS AND DUTIES. The district has the powers and duties provided by the 13 general law of this state, including Chapters 49 and 54, Water Code, 14 applicable to municipal utility districts created under Section 59, 15 Article XVI, Texas Constitution. 16 Sec. 8345.103. AUTHORITY FOR ROAD PROJECTS. (a) Under 17 Section 52, Article III, Texas Constitution, the district may 18 design, acquire, construct, finance, issue bonds for, improve, and 19 convey to this state, a county, or a municipality for operation and 20 maintenance macadamized, graveled, or paved roads described by 21 Section 54.234, Water Code, or improvements, including storm 22 drainage, in aid of those roads. 23 24 (b) The district may not exercise the powers provided by this section unless the district submits a petition to and obtains 25

26 approval from the Texas Commission on Environmental Quality as

27 required by Section 54.234, Water Code.

1 Sec. 8345.104. APPROVAL OF ROAD PROJECT. (a) The district may not undertake a road project authorized by Section 8345.103 2 3 unless: 4 (1) each municipality or county that will operate and 5 maintain the road has approved the plans and specifications of the road project, if a municipality or county will operate and maintain 6 7 the road; or 8 (2) the Texas Transportation Commission has approved the plans and specifications of the road project, if the state will 9 10 operate and maintain the road. (b) The district may not design, acquire, construct, 11 12 finance, issue bonds for, improve, or convey a road project unless the district obtains approval from the Texas Transportation 13 14 Commission. Sec. 8345.105. STREET REPAIR AND MAINTENANCE. (a) After 15 the 10th anniversary of the effective date of the Act creating this 16 17 chapter, the district, at the district's expense, shall repair and maintain the streets in the district. 18 19 (b) A district's repair and maintenance of a street under this section must meet all applicable construction standards and 20 regulations of Williamson County. 21 Sec. 8345.106. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE 22 OR RESOLUTION. The district shall comply with all applicable 23 24 requirements of any ordinance or resolution that is adopted under Section 54.016 or 54.0165, Water Code, and that consents to the 25 26 creation of the district or to the inclusion of land in the 27 district.

Sec. 8345.107. LIMITATION ON USE OF EMINENT DOMAIN. The 1 2 district may not exercise the power of eminent domain outside the 3 district to acquire a site or easement for: 4 (1) a road project authorized by Section 8345.103; or 5 (2) a recreational facility as defined by Section 6 49.462, Water Code. 7 [Sections 8345.108-8345.150 reserved for expansion] SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS 8 Sec. 8345.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The 9 10 district may issue, without an election, bonds and other 11 obligations secured by: 12 (1) revenue other than ad valorem taxes; or 13 (2) contract payments described by Section 8345.153. 14 (b) The district must hold an election in the manner 15 provided by Chapters 49 and 54, Water Code, to obtain voter approval before the district may impose an ad valorem tax or issue bonds 16 17 payable from ad valorem taxes. 18 (c) The district may not issue bonds payable from ad valorem 19 taxes to finance a road project unless the issuance is approved by a vote of a two-thirds majority of the district voters voting at an 20 election held for that purpose. 21 Sec. 8345.152. OPERATION AND MAINTENANCE TAX. (a) 22 If 23 authorized at an election held under Section 8345.151, the district 24 may impose an operation and maintenance tax on taxable property in the district in accordance with Section 49.107, Water Code. 25 26 (b) The board shall determine the tax rate. The rate may not 27 exceed the rate approved at the election.

Sec. 8345.153. CONTRACT TAXES. (a) In accordance with Section 49.108, Water Code, the district may impose a tax other than an operation and maintenance tax and use the revenue derived from the tax to make payments under a contract after the provisions of the contract have been approved by a majority of the district voters voting at an election held for that purpose.

7 (b) A contract approved by the district voters may contain a
8 provision stating that the contract may be modified or amended by
9 the board without further voter approval.

10 [Sections 8345.154-8345.200 reserved for expansion] SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS 11 12 Sec. 8345.201. AUTHORITY TO ISSUE BONDS AND OTHER OBLIGATIONS. The district may issue bonds or other obligations 13 payable wholly or partly from ad valorem taxes, impact fees, 14 15 revenue, contract payments, grants, or other district money, or any 16 combination of those sources, to pay for any authorized district 17 purpose.

18 Sec. 8345.202. TAXES FOR BONDS. At the time the district 19 issues bonds payable wholly or partly from ad valorem taxes, the 20 board shall provide for the annual imposition of a continuing 21 direct ad valorem tax, without limit as to rate or amount, while all 22 or part of the bonds are outstanding as required and in the manner 23 provided by Sections 54.601 and 54.602, Water Code.

24 <u>Sec. 8345.203. BONDS FOR ROAD PROJECTS. At the time of</u> 25 <u>issuance, the total principal amount of bonds or other obligations</u> 26 <u>issued or incurred to finance road projects and payable from ad</u> 27 <u>valorem taxes may not exceed one-fourth of the assessed value of the</u>

(b) The governor, one of the required recipients, has
19 submitted the notice and Act to the Texas Commission on
20 Environmental Quality.

21 The Texas Commission on Environmental Quality has filed (c) its recommendations relating to this Act with the governor, the 22 23 lieutenant governor, and the speaker of the house of representatives within the required time. 24

(d) All requirements of the constitution and laws of this
state and the rules and procedures of the legislature with respect
to the notice, introduction, and passage of this Act are fulfilled

1 and accomplished.

2 SECTION 4. This Act takes effect immediately if it receives 3 a vote of two-thirds of all the members elected to each house, as 4 provided by Section 39, Article III, Texas Constitution. If this 5 Act does not receive the vote necessary for immediate effect, this 6 Act takes effect September 1, 2009.
