5	SECTION 1. Title 6, Special District Local Laws Code, is
6	amended by adding Subtitle M to read as follows:

8	CHAPTER 9701. RED BLUFF WATER POWER CONTROL DISTRICT
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 9701.001. DEFINITIONS. In this chapter:
11	(1) "Director" means a member of the Red Bluff board.
12	(2) "Member district" means the following water
13	improvement districts and irrigation districts:

- 1 (3) "Red Bluff board" means the board of directors of
- 2 the Red Bluff District.
- 3 (4) "Red Bluff District" means the Red Bluff Water

- 5 Sec. 9701.002. NATURE OF DISTRICT. The Red Bluff District
- 6 is a water power control district in Loving, Pecos, Reeves, and Ward
- 7 Counties, created under and essential to accomplish the purposes of
- 8 Section 59, Article XVI, Texas Constitution.
- 9 Sec. 9701.003. DISTRICT TYPES ELIGIBLE FOR MEMBERSHIP. A
- 10 member district may be a water improvement district operating under
- 11 Chapter 55, Water Code, or an irrigation district operating under
- 12 Chapter 58, Water Code.
- 13 Sec. 9701.004. TERRITORY OF RED BLUFF DISTRICT. The
- 14 territory of the Red Bluff District is only that territory included
- 15 <u>in the combined territory of the member districts.</u>
- [Sections 9701.005-9701.050 reserved for expansion]
- 17 SUBCHAPTER B. ADMINISTRATIVE PROVISIONS
- Sec. 9701.051. APPOINTED BOARD OF DIRECTORS. (a) The Red
- 19 Bluff District is governed by a board of seven directors.
- 20 (b) The governing body of each member district shall appoint
- 21 one director to serve on the Red Bluff board. Each director
- 22 represents the member district from which the director was
- 23 appointed and serves at the pleasure of the governing body of that
- 24 member district.
- 25 (c) An\_elected official of any county, municipality, or
- 26 other political subdivision in the territory of the district may be
- 27 <u>appointed to and serve on the Red Bluff b</u>oard as a director without

- 1 penalty or forfeiture of office.
- 2 (d) If a vacancy occurs on the Red Bluff board, the member
- 3 district that appointed the director to the vacated position shall
- 4 appoint a person to fill the vacancy.
- 5 (e) Except as provided by this subsection, directors serve
- 6 staggered terms of six years. The initially appointed directors
- 7 shall draw lots to begin the staggering so that one or two directors
- 8 are appointed every two years.
- 9 (f) A director may not serve consecutive terms.
- Sec. 9701.052. COMPENSATION; REIMBURSEMENT. (a) A
- 11 <u>director is not entitled to compensation for performing the duties</u>
- 12 of a director but is entitled to reimbursement of expenses
- 13 necessarily incurred in performing the duties of a director.
- 14 (b) A position on the Red Bluff board may not be construed to
- 15 be a civil office of emolument for any purpose, including a purpose
- 16 <u>described by Section 40, Article XVI, Texas Constitution.</u>
- 17 Sec. 9701.053. DIRECTOR AS ACTING GENERAL MANAGER. A
- 18 director may serve as the acting general manager of the district
- 19 only:
- 20 (1) during the initial establishment of the appointed
- 21 Red Bluff board; or
- 22 (2) for a period not to exceed six months if a vacancy
- 23 occurs in the position of general manager.
- Sec. 9701.054. ORGANIZATIONAL MEETING. As soon as
- 25 practicable after all the initially appointed directors have
- 26 qualified under Section 49.055, Water Code, the directors shall
- 27 meet at a location in the Red Bluff District agreeable to a majority

- 1 of the directors. At the meeting, the directors shall elect
- 2 officers from among the directors and conduct any other district
- 3 business.
- 4 Sec. 9701.055. DISTRICT EMPLOYMENT RESTRICTION. The Red
- 5 Bluff District may not employ a person who is related to a director
- 6 within the third degree by consanguinity or affinity, as determined
- 7 under Subchapter B, Chapter 573, Government Code, during that
- 8 director's term of office. A district employee who is related
- 9 within the third degree by consanguinity or affinity to a person
- 10 appointed as a director shall resign from employment when that
- 11 director takes office.

- SUBCHAPTER C. POWERS AND DUTIES
- 14 Sec. 9701.101. GENERAL POWERS AND DUTIES. The Red Bluff
- 15 District has all of the rights, powers, privileges, authority,
- 16 functions, and duties provided by the general law of this state,
- 17 including Chapters 49 and 51, Water Code, Chapter 76, General Laws,
- 18 Acts of the 43rd Legislature, Regular Session, 1933 (Article 7807d,
- 19 Vernon's Texas Civil Statutes), and Chapter 19, Acts of the 43rd
- 20 Legislature, 1st Called Session, 1933 (Article 7807dd, Vernon's
- 21 Texas Civil Statutes), applicable to water power control districts
- 22 created under Section 59, Article XVI, Texas Constitution.
- 23 SECTION 2. (a) In this section, "member district" has the
- 24 meaning assigned by Section 9701.001, Special District Local Laws

- 1 precleared under Section 5, Voting Rights Act of 1965 (42 U.S.C.
- 2 Section 1973c), the board of directors of each member district
- 3 shall appoint a director to the board of the Red Bluff Water Power
- 4 Control District and file the certificate of appointment with the
- 5 board of the Red Bluff Water Power Control District.
- 6 (c) On the date a director's certificate of appointment is
- 7 filed under Subsection (b) of this section, a director appointed
- 8 under Subsection (b) of this section replaces the director elected
- 9 to represent the same member district.
- 10 SECTION 3. (a) The legal notice of the intention to
- 11 introduce this Act, setting forth the general substance of this
- 12 Act, has been published as provided by law, and the notice and a
- 13 copy of this Act have been furnished to all persons, agencies,
- 14 officials, or entities to which they are required to be furnished
- 15 under Section 59, Article XVI, Texas Constitution, and Chapter 313,

- 2 a vote of two-thirds of all the members elected to each house, as
- 3 provided by Section 39, Article III, Texas Constitution. If this
- 4 Act does not receive the vote necessary for immediate effect, this
- 5 Act takes effect September 1, 2009.
