- 15 search and rescue operation, but his heroic actions on that day
- 16 helped to save the life of fellow game warden Danny Tuggle; and

- 18 is fitting to remember the passion he brought to all his endeavors
- 19 and the positive way in which he touched the lives of those who were
- 20 privileged to know him; now, therefore, be it

- 22 hereby pay tribute to the memory of game warden Teyran Patterson and
- 23 extend deepest sympathy to his family: to his parents, Joe and Viann
