- 15 eight qualified rides during its years in the arena; and
- 16 WHEREAS, The Andrews Rodeo Company has also handled renowned
- 17 bulls such as Skoal's Outlaw Willie and Skat Kat, which, like
- 18 Bodacious, were honored with Bucking Bull of the Year honors;
- 19 official commendations have also been awarded to Mr. Andrews
- 20 himself, including his selection as the 2002 Stock Contractor of
- 21 the Year by the Professional Rodeo Cowboys Association; and
- 22 WHEREAS, A prominent figure in the world of rodeo,
- 23 Mr. Andrews and his livestock have been featured on television
- 24 programs and in newspaper and magazine articles, and he has become
