2 Texas, were greatly saddened by his passing on March 4, 2009, at the
3 age of 52; and

4 WHEREAS, A native Texan, Pat Barbee was born on August 24,
5 1956, in Paris, to Elbert Elmo Barbee, Jr., and Katheryne Patrick
6 Barbee; he attended Paris Junior College, earned a degree from
7 Texas Tech University, and pursued graduate studies at Texas A&M
8 University--Commerce; and

9 WHEREAS, He exchanged vows with the former LeAnn Starnes on
10 December 20, 1980, at the First United Methodist Church in Paris,
11 and through the years, the couple shared in the joy of welcoming
12 three beloved children into their family; and

13 WHEREAS, Mr. Barbee was employed with Williams Sporting Goods
14 for two decades, and after retiring, he went to work at Paris High
15 School for five years; and

16 WHEREAS, A congregant of First United Methodist Church, he
17 participated in local cultural activities through his longtime
18 involvement with the Paris Municipal Band, which he also served as
19 announcer, and the Paris Community Theatre, which benefited from
20 his leadership as president and board member, and from his talent as
21 an actor in many productions; and

23 Barbee will forever hold a treasured place in the hearts of those
24 fortunate enough to have shared in his love and friendship; now,
