2 Weaver of Paris, Texas, who passed away on April 29, 2009, at the
3 age of 100; and

6 life, the former Evelyn Campbell, in 1934, and the couple raised two
7 daughters, Carolyn and Kay; through the years, they welcomed into

10 Store for 43 years before retiring in 1987, and he served as a
11 director of the Retail Furniture Association; very active in his

14 moreover, he was a longtime congregant of First Presbyterian
15 Church, where he served as an elder, trustee, and treasurer; in his

19 long and rewarding life, Frank Weaver will be forever remembered
