HOUSE CONCURRENT RESOLUTION

1 WHEREAS, U.S. Marine Corporal Roy Cisneros of San Antonio

performed gallant and intrepid service in the Vietnam War; and

WHEREAS, Born on February 6, 1949, Roy Cisneros attended

4 Cenizo Park Elementary School, Truman Middle School, and Edgewood

High School; following his graduation in 1967, he joined the

6 marines and trained at Camp Pendleton, California; in December

7 1967, he deployed to Vietnam, where he became a squad leader with

8 Company B, 1st Battalion, 3rd Marines, 3rd Marine Division

9 (Reinforced), Fleet Marine Force; and

10 WHEREAS, On September 11, 1968, Corporal Cisneros was

conducting a reconnaissance in force in Quang Tri, the northernmost

12 province in the Republic of Vietnam, when his company came under

13 intense small arms and automatic weapons fire from an opposing

14 company of North Vietnamese soldiers occupying fortified positions

on a hill; during the ensuing combat, Corporal Cisneros skillfully

16 maneuvered his squad across the hazardous terrain and directed his

17 men's fire with devastating accuracy, destroying three enemy

18 bunkers; and

19 WHEREAS, With his squad pinned down by a heavy volume of fire

20 from a fourth emplacement, Corporal Cisneros advanced alone and

21 sought single-handedly to destroy the position; after firing a

22 light antitank assault weapon into the bunker, he hurled hand

23 grenades at the defenders and then opened fire with his rifle as he

24 aggressively continued his assault; disregarding his own safety, he

- 1 was delivering an effective attack on the emplacement when he was
- 2 mortally wounded; and
- 3 WHEREAS, The resolute determination and fighting spirit
- 4 demonstrated by Corporal Cisneros inspired all who observed him,
- 5 and he was instrumental in his unit's accounting for 45 North
- 6 Vietnamese soldiers confirmed killed; as a result of his actions,
- 7 Corporal Cisneros was posthumously awarded the Navy Cross, the
- 8 second highest honor for valor that can be bestowed on a marine; and
- 9 WHEREAS, Through his unhesitating selflessness and his
- 10 steadfast devotion to duty and this country, Corporal Roy Cisneros
- 11 embodied the highest ideals of the United States Marine Corps, and
- 12 his courageous efforts and immeasurable sacrifice are deserving of
- 13 honor by every American; now, therefore, be it
- RESOLVED, That the 81st Legislature of the State of Texas
- 15 hereby posthumously recognize the heroic actions of U.S. Marine
- 16 Corporal Roy Cisneros and express profound appreciation on behalf
- 17 of all Texans; and, be it further
- 18 RESOLVED, That an official copy of this resolution be
- 19 prepared for his family as an expression of high regard by the Texas
- 20 House of Representatives and Senate.
