

HOUSE CONCURRENT RESOLUTION

1           WHEREAS, The conference committee report for House Bill No. 3  
2 has been adopted by the house of representatives and the senate and  
3 is being prepared for enrollment; and

4           WHEREAS, The bill contains technical and typographical  
5 errors that should be corrected; now, therefore, be it

6           RESOLVED by the 81st Legislature of the State of Texas, That  
7 the enrolling clerk of the house of representatives be instructed  
8 to make the following corrections:

9           (1) On page 25, line 12, strike "39.301(b)(4)" and  
10 substitute "39.301(c)(5)".

11           (2) Strike page 27, line 26, through page 28, line 3, and  
12 substitute the following:

13           (n) A student who is promoted by a grade placement committee  
14 under this section must be assigned in each subject in which the  
15 student failed to perform satisfactorily on an assessment  
16 instrument specified under Subsection (a) to a teacher who meets  
17 all state and federal qualifications to teach that subject and  
18 grade.

19           (3) On page 28, line 6, strike "(b-3), (b-4), (b-5), (b-6),  
20 (b-7), and (b-8)" and substitute "(b-3) through (b-10)".

21           (4) On page 30, strike lines 7-23 and substitute the  
22 following:

23           (b-3) In adopting rules to provide students with the option  
24 described by Subsection (b-1)(1)(A), the State Board of Education

1 must approve a variety of mathematics and science courses that may  
2 be taken after the completion of Algebra II and physics to comply  
3 with the recommended program requirements.

4 (b-4) A school district may offer the curriculum described  
5 in Subsection (b-1)(1)(A) in an applied manner. Courses delivered  
6 in an applied manner must cover the essential knowledge and skills,  
7 and the student shall be administered the applicable end-of-course  
8 assessment instrument as provided by Sections 39.023(c) and 39.025.

9 (b-5) A school district may offer a mathematics or science  
10 course to be taken by a student after completion of Algebra II and  
11 physics to comply with the recommended program requirements in  
12 Subsection (b-1)(1)(A). A course approved under this subsection  
13 must be endorsed by an institution of higher education as a course  
14 for which the institution would award course credit or as a  
15 prerequisite for a course for which the institution would award  
16 course credit.

17 (5) On page 30, line 24, strike "(b-4)" and substitute  
18 "(b-6)".

19 (6) On page 31, line 8, strike "(b-5)" and substitute  
20 "(b-7)".

21 (7) On page 31, line 17, strike "(b-6)" and substitute  
22 "(b-8)".

23 (8) On page 31, line 21, strike "(b-7)" and substitute  
24 "(b-9)".

25 (9) On page 32, line 5, strike "(b-8)" and substitute  
26 "(b-10)".

27 (10) On page 69, lines 16-22, strike "subchapter. If the

1 district received an accreditation status of accredited-warned or  
2 accredited-probation for the preceding school year or if any campus  
3 performed below a standard required under this subchapter in the  
4 preceding school year, the commissioner shall notify the district  
5 or campus of a subsequent such designation on or before June 15" and  
6 substitute "subchapter".

7 (11) On page 77, line 16, between "year" and "the", insert a  
8 comma.

9 (12) On page 106, line 8, strike "compare" and substitute "a  
10 comparison of".

11 (13) On page 125, line 23, strike "ELIGIBILITY FOR  
12 DISTINCTION DESIGNATION. (a)" and substitute "DISTINCTION  
13 DESIGNATIONS."

14 (14) On page 126, strike lines 2-24.

15 (15) On page 126, line 26, strike "(a) The commissioner  
16 shall award a".

17 (16) Strike page 126, line 27, through page 127, line 3.

18 (17) On page 127, strike lines 4-11 and substitute the  
19 following:

20 The commissioner by rule shall establish a recognized and  
21 exemplary rating for awarding districts and campuses an academic  
22 distinction designation under this subchapter. In establishing the  
23 recognized and exemplary ratings, the commissioner shall adopt  
24 criteria for the ratings, including:

25 (1) percentages of students who:

26 (A) performed satisfactorily, as determined  
27 under the college readiness performance standard under Section

1 39.0241, on assessment instruments required under Section  
2 39.023(a), (b), (c), or (l), aggregated across grade levels by  
3 subject area; or

4 (B) met the standard for annual improvement, as  
5 determined by the agency under Section 39.034, on assessment  
6 instruments required under Section 39.023(a), (b), (c), or (l),  
7 aggregated across grade levels by subject area, for students who  
8 did not perform satisfactorily as described by Paragraph (A); and  
9 (2) other factors for determining sufficient student  
10 attainment of postsecondary readiness.

11 (18) On page 141, line 6, strike "instruments" and  
12 substitute "instrument".

13 (19) On page 158, lines 12-14, strike "accreditation status  
14 [~~performance rating~~] of the district[~~, as determined~~] under Section  
15 39.052 [39.072]" and substitute "accreditation status and  
16 performance rating of the district[~~, as determined~~] under Sections  
17 39.052 and 39.054 [Section 39.072]".

18 (20) On page 168, line 19, strike "developed".

19 (21) On page 178, line 7, strike "28.002(c-3)" and  
20 substitute "28.002(c-1)".

21 (22) On page 178, line 9, between "39.023(e)" and "and",  
22 insert ", Education Code, as amended by this Act".

23 (23) On page 178, line 10, strike "amended" and substitute  
24 "added".

25 (24) On page 178, strike lines 11-13.

26 (25) On page 178, line 14, strike "(d)" and substitute  
27 "(c)".

1           (26) On page 178, line 17, strike "(e)" and substitute  
2 "(d)".

3           (27) On page 178, line 17, strike "Subsection (f)" and  
4 substitute "Subsection (e)".

5           (28) On page 178, line 22, strike "(f)" and substitute  
6 "(e)".
