20 president, vice president, and treasurer of the Urban Management
21 Assistants of North Texas, and she has served on the professional
22 development committee of the Texas City Management Association; she
23 is an active member of the North Texas City Management Association

2 individual has also found time to give back to her community as a
3 member of the Junior League of Richardson and Altrusa
4 International; a graduate of Leadership Richardson and the Citizens
5 Police Academy, she also sits on the editorial board of *Richardson*

7 WHEREAS, The many contributions of Ms. Thames to the civic
8 spirit and welfare of Richardson have been recognized with the 2008
9 Linda Keithley Award for Women in Public Management from the North
10 Central Texas Council of Governments, and in 2006, she was named
11 Outstanding Woman of the Year in the government category by Altrusa
12 International; and

14 their daughters, Sarah and Katherine, Michelle Thames is
15 contributing greatly to the future of the dynamic community in
