- 7 his nation's call to arms as a young man, he served two tours of duty
- 8 in Vietnam; and

- 10 began when he joined the Harris County Sheriff's Office in April of
- 11 1973; after working in the detention division for two years, he
- 12 became a patrolman; within a year, he was promoted to the detective
- 13 bureau; and
- WHEREAS, During his 32 years with the bureau, Detective Keen
- 15 investigated vice, property crime, domestic violence cases, and
- 16 robberies; at the time of his death, this dedicated peace officer
- 17 was engaged in the recovery from Hurricane Ike; and
- 18 WHEREAS, Detective Keen was a leader in his profession; he
- 19 served for a number of years as vice chairman of the Gulf Coast
- 20 Criminal Investigators Association, where he worked to promote
- 21 coordination between Houston area law enforcement agencies and
- 22 local businesses; in 1982, he was named a 100 Club Officer of the
- 23 Year, and throughout his career, he exemplified the virtues of
- 24 courage and integrity and demonstrated an unwavering commitment to

- 8 and welfare of the public, and Detective Tommy Keen has earned a
