1 WHEREAS, Rose Shaw Special Emphasis School in Corpus Christi
2 was named a 2008 No Child Left Behind--Blue Ribbon School, the
3 highest national designation a school can receive; and

4 WHEREAS, The Blue Ribbon Schools Program was created by the
5 U.S. Department of Education in 1982 and was redesigned in 2002
6 under the No Child Left Behind Act; to qualify for nomination,
7 schools must demonstrate academic superiority within their state or
8 show dramatic gains in student achievement; and

9 WHEREAS, One of only 26 schools in the state to receive this
10 prestigious award, Rose Shaw SES opened in 2005 and enrolls
11 students in prekindergarten through the fifth grade; the school's
12 mission is to create a place where every student can learn with the
13 help of staff, parents, and the community; skillfully led by
14 principal Rafael Silva and assistant principal Laura
15 Quiroz-Colunga, Rose Shaw SES was also rated one of the best public
16 schools in the Lone Star State by *Texas Monthly* magazine in 2006 and
17 2007; and

18 WHEREAS, Through commitment, hard work, and perseverance,
19 the teachers and students of Rose Shaw Special Emphasis School have
20 accomplished a record of academic excellence, and their outstanding
21 achievements were duly recognized with this Blue Ribbon School
22 designation; now, therefore, be it

24 Legislature hereby honor Rose Shaw Special Emphasis School on its
