4 WHEREAS, The Blue Ribbon Schools Program was created by the
5 U.S. Department of Education in 1982 and was redesigned in 2002
6 under the No Child Left Behind Act; to qualify for nomination,
7 schools must demonstrate academic superiority within their state or
8 show dramatic gains in student achievement; and

9 WHEREAS, One of only 26 schools in the state to receive this
10 prestigious award, Anderson Elementary has a current enrollment of
11 more than 600 students in kindergarten through the fifth grade;
12 skillfully led by principal Teresa Wilkinson, this notable
13 institution follows the motto, "Believe! Achieve! Succeed!"; and

15 the teachers and students of Anderson Elementary have attained a
16 record in which they may take justifiable pride, and their
