## RESOLUTION

1 WHEREAS, Albert H. Burns has dedicated much of his life to 2 serving his fellow citizens and making notable contributions in 3 behalf of his beloved hometown; and

WHEREAS, Born in Tenaha on September 30, 1924, Albert Burns 4 5 was raised in that East Texas community and graduated from Tenaha High School in 1942; soon thereafter, he answered his nation's call 6 7 to duty, and at the age of 18, he joined the U.S. Army Air Corps and was stationed in such locales as North Africa and Austria during 8 9 World War II; on his discharge from the military, he returned to the 10 Lone Star State and settled in Tenaha; through the years, he worked as a real estate broker, a businessman in the timber industry, and a 11 12 rural mail carrier, and he was the publisher and editor of a weekly newspaper for Tenaha and the surrounding areas, the East Texas 13 14 Light; and

WHEREAS, Despite his busy professional life, Mr. Burns has 15 16 found the time to distinguish himself through his community involvement, earning the nickname "Mr. Tenaha"; he has served as 17 president of the Tenaha Businessmen's Association and of the board 18 of the Tenaha Independent School District, and he is a deacon at the 19 20 First Baptist Church of Tenaha; in addition, he has been affiliated with the American Legion Post and has held positions in municipal 21 22 government; and

23 WHEREAS, This esteemed Texan is a steward of the history and 24 culture of Tenaha, and for his efforts, he has garnered praise from

1 the Shelby County Historical Society; Mr. Burns was also honored 2 with the Community Builder Award from the Tenaha Masonic Lodge, the 3 Man of the Year and 100 Men of East Texas designations, and 4 induction into the Tenaha Schools Hall of Fame; moreover, in 1996, 5 he received U.S. Congressional special community recognition; and

6 WHEREAS, In all of his endeavors, Mr. Burns enjoys the love 7 and support of his family; devoted to his wife, the late Virginia 8 Burns, throughout a marriage that spanned nearly six decades, he is 9 the proud father of three children, Linda, Bob, and Barry; he has 10 also known the joy of welcoming six grandchildren and two 11 great-grandchildren into the world; and

12 WHEREAS, A kind and generous man, Albert Burns is an 13 inspiration to all who are fortunate enough to know him, and he may 14 indeed reflect with great pride on the positive impact he has had on 15 his community; now, therefore, be it

16 RESOLVED, That the House of Representatives of the 81st Texas 17 Legislature hereby honor Albert H. Burns for his outstanding civic 18 engagement and extend to him sincere best wishes for continued 19 happiness; and, be it further
