- 1 WHEREAS, The Texas House of Representatives is pleased to

- 5 WHEREAS, Tarrant County was created in 1849 and named for
- 6 General Edward H. Tarrant; the third most populous county in Texas,
- 7 it is home to the international headquarters of such corporate
- 8 giants as American Airlines, Burlington Northern Santa Fe, Pier 1
- 9 Imports, and RadioShack; and
- 10 WHEREAS, Located in North Central Texas on the Grand Prairie
- 11 and the Blackland Prairie, Tarrant County is a popular area for
- 12 vacationing; the county boasts some of the Lone Star State's most
- 13 outstanding cultural attractions, including the Kimbell Art
- 14 Museum, the Amon G. Carter Museum, the Modern Art Museum of Fort
- 15 Worth, the Fort Worth Museum of Science and History, and the
- 16 National Cowgirl Museum and Hall of Fame; and
- 17 WHEREAS, The county is home to two of the leading teams in
- 18 professional sports: in Arlington the Texas Rangers are
- 19 headquartered at Rangers Ballpark, a traditional-style baseball
- 20 stadium at the center of a 270-acre entertainment complex, and
- 21 starting in 2009, the Dallas Cowboys, "America's Team," will be
- 22 playing in their new, state-of-the-art, domed stadium; and
- 23 WHEREAS, Nationally famous for such tourism centers as the
- 24 Fort Worth Stockyards and Six Flags Over Texas, Tarrant County is

- 2 Old West is still present today in the county's ranchland, museums,
- 3 art, and recreational centers; and
- WHEREAS, Tarrant County is also an important national and
- 5 international transportation crossroads located at the geographic
- 6 center of the hemisphere and at the intersection of a number of
- 7 major highway and rail corridors; moreover, it features such
- 8 outstanding air transportation facilities as the Dallas-Fort Worth
- 9 International Airport, Alliance Airport, and Meacham International
- 10 Airport; and
- 11 WHEREAS, The economic stability and diversity of the county
- 12 owe much to the leadership provided by the Coalition of Tarrant
- 13 County Chambers of Commerce, which represents more than 10,000
- 14 business organizations and brings together 25 chambers of commerce
- 15 from throughout Tarrant County; and
