- 20 recognized for the quality of its brews, and its awards include a
- 21 bronze medal at the 2008 World Beer Cup and best in class honors for
- 22 four consecutive years at the United States Beer Tasting

- 24 WHEREAS, Though it draws inspiration from the past, the

- 2 sustainable energy practices; all of the brewery's electricity
- 3 comes from renewable resources, and the company is working hard to

- 7 business and cultural practices while contributing to the economy
