RESOLUTION

- 1 WHEREAS, Family and friends are mourning the loss of John
- 2 Paul Barnich of Houston, who died on February 2, 2009, at the age of
- 3 63; and
- WHEREAS, John Barnich was born to Aileen and Bill Barnich,
- 5 Jr., of Cheboygan, Michigan, on September 25, 1945, and grew up on
- 6 nearby Mullett Lake; he earned a bachelor's degree in psychology
- 7 from Michigan State University in 1968; and
- 8 WHEREAS, After moving to Houston in 1969, Mr. Barnich taught
- 9 for 10 years in the Houston Independent School District; he was a
- 10 gifted and energetic teacher, designing a psychology program for
- 11 the district and working with the Federal Bureau of Investigation
- 12 to create a pilot program in police administration, which grew into
- 13 the HISD High School for Law Enforcement and Criminal Justice; and
- 14 WHEREAS, Mr. Barnich was a student council sponsor and a
- 15 building steward for the Houston Federation of Teachers; he was
- 16 recognized by Waltrip High School in 1973 as an Outstanding Young
- 17 Educator, and in 1978, he earned a Teacher of the Year Achievement
- 18 Award; and
- 19 WHEREAS, In 1977, Mr. Barnich spent six months in India
- 20 studying comparative religion as a Fulbright scholar; returning to
- 21 Texas, he earned his law degree from South Texas College of Law in
- 22 1980, and he opened his practice in 1981; he worked for Houston
- 23 Volunteer Lawyers and was a founder of the Bar Association for Human
- 24 Rights; he also lectured on the law for Thurgood Marshall School of

- 1 Law, Texas Southern University, the Texas Human Rights Foundation,
- 2 and the Houston Bar Association; and
- 3 WHEREAS, Mr. Barnich was a pioneering activist on behalf of
- 4 the rights of gay, lesbian, bisexual, and transgendered people; he
- 5 took on much pro bono work on behalf of the GLBT community, and one
- 6 of his cases was joined by the U.S. Department of Justice and
- 7 resulted in people with AIDS being included in the Americans with
- 8 Disabilities Act; in another case, he effected an important change
- 9 in the way dentists treat people with AIDS; and
- 10 WHEREAS, A cofounder of AIDS Foundation Houston, Mr. Barnich
- 11 served as chair of the organization's board from 1990 to 1994;
- 12 during his tenure, he helped obtain a major community development
- 13 grant for AIDS housing, and developed a grant for AIDS education in
- 14 the county Juvenile Detention Center; he also served on the board of
- 15 the AIDS Equity League from 1988 to 1992 and played an active role
- 16 in the Houston GLBT Political Caucus; and
- WHEREAS, In 1999, Mr. Barnich was appointed to be Houston's
- 18 first openly gay municipal judge, and he served with distinction in
- 19 that post until 2007; he continued to serve as a part-time
- 20 adjudication hearing officer until his death; and
- 21 WHEREAS, For his efforts in behalf of equality and social
- 22 justice, Mr. Barnich was named the Texas Human Rights Foundation
- 23 Advocate of the Year in 1992, and two years later, he earned the
- 24 Humanitarian Award from the Conference on AIDS in America; he was
- 25 also recognized with the Houston Humanitarian Award and the
- 26 Humanitarian Award from the GLBT Political Caucus; and
- 27 WHEREAS, Mr. Barnich possessed a ready wit; when he was asked

- 1 how being gay would make him different from other municipal judges,
- 2 he quipped that he would upgrade the courtroom sound system to play
- 3 show tunes; a sign on his office door read, "Be nice or leave"; and
- WHEREAS, An outspoken champion for the causes he believed in,
- 5 John Barnich worked tirelessly to improve the lives of others, and
- 6 his legacy will long resonate in the community that he loved; now,
- 7 therefore, be it
- 8 RESOLVED, That the House of Representatives of the 81st Texas
- 9 Legislature hereby pay tribute to the life of the Honorable John
- 10 Paul Barnich and extend sincere condolences to the members of his
- 11 family: to his brothers, Rick Barnich and Bill Barnich III; to his
- 12 sisters, Mary Barnich and Martha Jo Vanderberg; and to his other
- 13 relatives and many friends; and, be it further
- 14 RESOLVED, That an official copy of this resolution be
- 15 prepared for his family and that when the Texas House of
- 16 Representatives adjourns this day, it do so in memory of John
