- 1 WHEREAS, General Michael W. Hagee, United States Marine Corps
- 2 (Ret.), of Fredericksburg, has been appointed executive director of
- 3 the Admiral Nimitz Foundation, effective January 5, 2009; and
- WHEREAS, A member of the foundation's board since 2007,
- 5 General Hagee will play a vital role in advancing the work of that
- 6 organization, which has supported the National Museum of the
- 7 Pacific War since 1970; located on nine acres in Fredericksburg and
- 8 operated under the auspices of the Texas Historical Commission, the
- 9 museum is the only institution in the continental United States
- 10 dedicated exclusively to telling the story of the Pacific theater
- 11 battles of World War II; and
- 12 WHEREAS, Born and raised in Fredericksburg, General Hagee
- 13 joined the navy in 1963 and graduated with distinction from the U.S.
- 14 Naval Academy in 1968; during a career of nearly four decades, he
- 15 served as commanding general of the 1st Marine Division and the I
- 16 Marine Expeditionary Force, as senior military assistant to the
- 17 deputy secretary of defense, as executive assistant to the director
- 18 of central intelligence, as deputy director of operations for the
- 19 U.S. European Command, and as director of strategic plans and
- 20 policy for the U.S. Pacific Command; he became the 33rd commandant
- 21 of the marine corps in 2003 and served as a member of the Joint
- 22 Chiefs of Staff from 2004 until his retirement from the service in
- 23 2007; and
- 24 WHEREAS, General Hagee's numerous military awards include

- 1 the Defense Distinguished Service Medal with two palms, the Defense
- 2 Superior Service Medal, the Legion of Merit with two gold stars, the
- 3 Bronze Star with Combat "V," and the Defense Meritorious Service
- 4 Medal; he has also received personal decorations from a number of
- 5 foreign countries; and
- 6 WHEREAS, This distinguished Texan holds a bachelor's degree
- 7 in electrical engineering from the U.S. Naval Academy, a master's
- 8 degree in electrical engineering from the U.S. Naval Postgraduate
- 9 School, and a master's degree in national security studies from the
- 10 U.S. Naval War College; and
- 11 WHEREAS, General Michael Hagee has rendered exceptional
- 12 service to this country in both war and peace, and Texans are indeed
- 13 fortunate that he is devoting his time and talents to furthering the
- 14 mission of the National Museum of the Pacific War; now, therefore,
- 15 be it
