RESOLUTION

1 WHEREAS, The United States Coast Guard Auxiliary plays a

2 crucial role in the operations of this country's oldest continuing

3 seagoing service; and

WHEREAS, Founded by the U.S. Congress in 1939 and now

5 numbering some 30,000 active members, the auxiliary is the

6 uniformed volunteer component of the coast guard and supports that

7 branch of the armed forces in all its missions, save for military

8 and law enforcement actions; and

9 WHEREAS, Each year, members of the auxiliary devote more than

10 2 million hours to coast guard activities; on any given day,

11 auxiliarists throughout the country will assist 28 people, save 1

12 life, come to the aid of 10 vessels, conduct more than 60 safety

13 patrols, and participate in 100 operational support missions and

14 nearly 50 administrative support missions; they will also educate

15 more than 350 individuals about boating safety and perform

16 approximately 300 vessel safety checks; and

WHEREAS, Auxiliary members attached to U.S. Coast Guard Air

18 Station Houston render exceptional service, both in performing

19 routine assignments and in augmenting the station's emergency

20 response capability; the demands on this air station and its

21 auxiliary are particularly heavy, owing to the region's

22 vulnerability to hurricanes and tropical storms, the presence of an

23 area population surpassing five million, and the extensive volume

24 of commercial shipping on this part of the coast; and

- 10 Air Station Houston and across the nation adhere faithfully to the
- 11 coast guard's motto, "Always Ready," and they are providing service
- 12 of immeasurable value; now, therefore, be it

- 15 Guard Auxiliary at Air Station Houston and around the country for
