1           WHEREAS, Residents of Pasadena lost a valued community leader  
2 with the passing of Donald Ray Carpenter, Sr., on March 1, 2009, at  
3 the age of 77; and

4           WHEREAS, Born to William and Claudia Carpenter in Kosse on  
5 July 5, 1931, Donald Carpenter graduated from John H. Reagan High  
6 School and went on to study at The University of Texas and the  
7 University of Houston; he began working for Southwestern Bell  
8 Telephone Company at the age of 17 as a mail room clerk and was  
9 employed by the company for 40 years, eventually retiring as  
10 district manager; moreover, he served his nation as a member of the  
11 Air Force Reserve; and

12           WHEREAS, Mr. Carpenter devoted himself to his community in  
13 the years following his retirement, serving as president of the  
14 Pasadena Rotary Club and the Pasadena Chamber of Commerce and as  
15 chief of staff for the City of Pasadena; possessing a deep knowledge  
16 of local issues and a strong rapport with elected officials, he was  
17 a sought-after political advisor whose opinions were highly  
18 respected, and he was an active member of Park Place Masonic Lodge  
19 and a prominent supporter of the YMCA, the Salvation Army, and  
20 several other charitable causes; when not busy with other projects,  
21 he relished spending time on the golf course; and

22           WHEREAS, In all of his endeavors, Mr. Carpenter enjoyed the  
23 love and support of his wife, Barbara, with whom he shared nearly  
24 six decades of marriage; the couple were blessed with three

1 children, Donald, Darrell, and Barbara, and had the pleasure of  
2 welcoming six grandchildren and three great-grandchildren into  
3 their family; and

4 WHEREAS, Donald Carpenter lived a caring and purposeful life,  
5 and he will forever hold a treasured place in the hearts of all  
6 those who were privileged to know him; now, therefore, be it

8 Legislature hereby pay tribute to the memory of Donald Ray  
9 Carpenter, Sr., and extend sincere sympathy to the members of his
