14 volunteered his time to numerous local organizations; he is a  
15 commissioner on the Housing Authority of the City of Odessa, and he  
16 is on the board of the Odessa Elderly Housing Corporation and the  
17 Odessa Industrial Development Corporation; he also serves on the  
18 Permian Basin Advisory Council for the Texas Tech Health Sciences  
19 Center and the Legal Advisory Council for the Catholic Diocese of  
20 San Angelo, and he is a past president of Catholic Charities Odessa;  
21 in addition, Mr. Hollmann has been involved with the Odessa Chamber  
22 of Commerce as a member and chairman of various committees, as well  
23 as the board of directors, and he has received both the Heritage of  
24 Odessa Foundation Award and the Citizen of the Year designation;
