## RESOLUTION

1 WHEREAS, The city of Pittsburg, Texas, lost a distinguished 2 community leader with the passing of the Honorable D. H. Abernathy 3 on September 24, 2008, at the age of 96; and

WHEREAS, Mr. Abernathy took a prominent role in the government of his community for 57 years, 52 of which he served as mayor; his service as an elected official began in 1949, when he was elected to the city council, and concluded with his retirement as mayor in 2006, when he was in his early 90s; during that period, he missed only eight city council meetings, which is a testament to his dedication to his work as a public servant; and

WHEREAS, Hailing from a prominent area family, Mr. Abernathy was the great-great-nephew of W. H. Pitts, for whom Pittsburg is named; he graduated from the city's high school in 1929 and went on to attain a mechanical engineering degree from the University of Oklahoma; employment in Oklahoma and Arkansas kept him away from his hometown for a number of years, but he ultimately returned to Texas and worked as the city electrical inspector for 23 years and as an employee of Lone Star Steel for 30 years; he and his wife, Laverne, raised three children and later had the pleasure of seeing their family extend to third, fourth, and fifth generations; and

21 WHEREAS, Mayor Abernathy's dedication to his community and 22 county extended beyond his duties as an elected official; he was 23 active in the Camp County Arts Council, the Camp County Ambulance 24 Service, and First Methodist Church, and he was president of the

- 1 Camp County Chamber of Commerce; his input benefited regional and
- 2 state organizations as well, including the East Texas Council of
- 3 Governments and the Texas Municipal League, both of which he served
- 4 as president, as well as the Fire Advisory Committee for the Texas
- 5 Forest Service and the Northeast Texas Economic Development
- 6 District executive committee; and
- 7 WHEREAS, Committed to the ongoing development of
- 8 northeastern Texas, Mayor Abernathy became a vocal advocate for
- 9 improving the region's network of roads, and he was a founder and
- 10 president of the East Texas Gulf Highway Association and a member of
- 11 the Texas Good Roads/Transportation Association; his efforts were
- 12 honored with the Road Hand Award from the Texas State Highway
- 13 Commission and with the naming of D. H. Abernathy Boulevard;
- 14 moreover, his many achievements in office garnered a number of
- 15 other accolades through the years, including Man of the Year Awards
- 16 from both the Camp County Chamber of Commerce and the Pittsburg
- 17 Business and Professional Women; and
- 18 WHEREAS, D. H. Abernathy helped guide Pittsburg and the
- 19 surrounding area through an era that encompassed tremendous change,
- 20 yet his allegiance to faithfully serving his constituents was
- 21 constant, and his legacy of wise leadership will resonate far into
- 22 the future; now, therefore, be it
- 23 RESOLVED, That the House of Representatives of the 81st Texas
- 24 Legislature hereby pay tribute to the life of Mayor D. H. Abernathy
- 25 and extend deepest condolences to the members of his family: to his
- 26 wife, Laverne Abernathy; to his children, W. David Abernathy, Mary
- 27 Lou Spradling, and Betty Ann Harrel and her husband, Dennis;
