- 1 WHEREAS, Residents of Victoria lost a cherished friend and
- 2 renowned philanthropist with the passing of Mary Katherine
- 3 Welhausen Borchers on February 28, 2009, at the age of 84; and
- 4 WHEREAS, The daughter of Carl Clarence Welhausen and Mary
- 5 Elizabeth McBride Welhausen, the former Mary Katherine Welhausen
- 6 was born in Yoakum on August 10, 1924, into the family that founded
- 7 Tex Tan Leather Company, which eventually became a division of
- 8 Tandy Corporation, the company known today as RadioShack
- 9 Corporation; an honors graduate of Yoakum High School, she was
- 10 Queen of the Yoakum Tom-Tom Festival in 1946, and she earned a
- 11 bachelor's degree in business administration with honors from The
- 12 University of Texas at Austin, where she also took graduate courses
- 13 in personnel management; and
- 14 WHEREAS, After meeting in high school, she and Lieutenant
- 15 Charles Borchers were joined in matrimony in August 1947, following
- 16 his military service during World War II; the couple settled in
- 17 Victoria in 1957; and
- 18 WHEREAS, Mrs. Borchers worked as an administrator at The
- 19 University of Texas Medical Branch at Galveston and later as a
- 20 personal business, investment, and family trust manager for more
- 21 than three decades; she was also a general partner, along with her
- 22 husband and daughters, in Borchers Southern Y Ranches; and
- 23 WHEREAS, Engaged in the community, Mrs. Borchers was
- 24 affiliated with numerous local organizations, including the

- 1 Victoria Regional Museum Association, the Victoria County
- 2 Historical Commission, the American Red Cross, and the Cultural
- 3 Council of Victoria, and she assisted with such projects as the
- 4 restoration of the Victoria County Courthouse; she was a member of
- 5 the Victoria 100 Club, the Texas Federation of Women's Clubs,
- 6 Daughters of the American Revolution, Club 20, Daughters of the
- 7 Republic of Texas, and many others; she also participated in the
- 8 Junior League of Victoria, and she received its "Sustainer of the
- 9 Year Award"; moreover, this esteemed Texan was recognized with the
- 10 Distinguished Citizen Award of Victoria in 2002; and
- 11 WHEREAS, Among the myriad organizations that benefited from
- 12 the support of Mrs. Borchers and her husband are the Victoria
- 13 Symphony, the Children's Discovery Museum, and the Victoria
- 14 Performing Arts Center, home of the Dr. Charles and Mary Katherine
- 15 Borchers Performance Hall; Mrs. Borchers further contributed to her
- 16 alma mater and a number of its institutions, including the McCombs
- 17 School of Business; she was a member of such groups as the
- 18 Ex-Students Association, the Chancellor's Council Executive
- 19 Committee, and the Longhorn Foundation, and she was named a Texas
- 20 Exes "Legend"; and
- 21 WHEREAS, Mary Katherine Borchers was an inspiration to all
- 22 who were fortunate enough to know her, and she leaves behind an
- 23 extraordinary legacy of compassion and goodwill that will not soon
- 24 be forgotten; now, therefore, be it
- 25 RESOLVED, That the House of Representatives of the 81st Texas
- 26 Legislature hereby pay tribute to the life of Mary Katherine
- 27 Welhausen Borchers and extend sincere sympathy to the members of

- 1 her family: to her husband of 61 years, Dr. Charles Lewis Borchers;
- 2 to her daughters, Mary Kay Borchers and Charla Borchers Leon and her
- 3 husband, Robert; to her brothers-in-law, William, Otto, and Marion
- 4 Borchers, and Don G. Kaspar; to her 12 nieces and nephews and 24
- 5 great-nieces and great-nephews; and to her other relatives and many
- 6 friends; and, be it further
