6 has taught at Bellville High School since 1998, focusing on

8 WHEREAS, In addition to the myriad responsibilities inherent
9 in her role as an educator, Becky Bader has lent her time and
10 talents to a host of extracurricular endeavors; she has served as
11 the UIL academic coordinator, literary criticism coach, and ready
12 writing coach, and one of her students won the 2006 Class 3A state
13 championship in ready writing; she has also sponsored the BHS
14 Writing Club and the VFW Voice of Democracy contest, and she
15 continually encourages her students to participate in such
16 competitions as the Lions Club speech and essay contests; moreover,
17 on the state level, she fulfilled a four-year term on the Texas
18 Education Agency development and review committee for the Texas
19 Assessment of Knowledge and Skills; and

20 WHEREAS, Mrs. Bader has been recognized by a number of other
21 organizations as well as by her students; she was named the Wal-Mart
22 Teacher of the Year in 2005, received the Bellville ISD Golden Bell
23 and Starfish Awards, has been nominated yearly to *Who's Who Among*
24 *American Teachers*, and was presented an Academic Excellence Award

3 support of her husband, Ian Bader, who was named Citizen of the Year
4 in 1998; and

8 high regard in which she is held by her fellow citizens; now,
