- 1 WHEREAS, Willacy County lost a respected leader with the
- 2 passing of the Honorable Simon Salinas on March 9, 2009, at the age
- 3 of 72; and
- WHEREAS, A native of the Lone Star State, Simon Salinas was
- 5 born in Harlingen on January 26, 1937, to Benito and Elena Salinas;
- 6 he grew up as a migrant worker, and this early experience led him to
- 7 recognize the importance of hard work and perseverance; he enlisted
- 8 in the United States Navy and ended his tour of duty as a seaman,
- 9 earning the Navy Occupation Service Medal with Europe Clasp award
- 10 for his distinguished service; and
- 11 WHEREAS, Judge Salinas became involved in community affairs
- 12 in 1961 as an advocate for a clean water supply for the citizens of
- 13 Sebastian, and by 1965 he was chairman of the newly formed Sebastian
- 14 Municipal Water District; he went on to serve several terms on the
- 15 board of trustees of the Lyford Consolidated Independent School
- 16 District, and in 1984 he was elected county commissioner for
- 17 Willacy County; and
- WHEREAS, This notable Texan was elected county judge in 1994,
- 19 a position he held until his retirement in 2007; during his tenure,
- 20 he led the county from a \$1.2 million budget deficit to a
- 21 financially sound, balanced budget and helped it to gain access to
- 22 more than \$15 million in state community grants, much of the funds
- 23 of which went to address the environmental, health, and basic
- 24 infrastructure needs of colonia residents; and

- 1 WHEREAS, Judge Salinas also played an integral role in the
- 2 development of a prison and a detention center in Willacy County,
- 3 and he worked to encourage the aerospace technology industry to
- 4 come to the county; and
- 5 WHEREAS, Devoted to his family, he shared many years with his
- 6 wife, Estella, and he lovingly helped to raise four children, Noemi
- 7 Chestnutt, Maria Elena Salinas, Rosario Cedillo, and Joe Salinas;
- 8 after retiring, he returned to his farm, where he tended to his
- 9 watermelon patches and other crops; in his free time, he enjoyed
- 10 traveling the state to find and collect vintage tractors; and
- 11 WHEREAS, Simon Salinas made significant contributions to
- 12 Willacy County and its citizens, and although he will be missed by
- 13 all who knew him, his spirit will live on in their hearts for years
- 14 to come; now, therefore, be it
- RESOLVED, That the House of Representatives of the 81st Texas
- 16 Legislature hereby pay tribute to the life of the Honorable Simon
- 17 Salinas and extend deepest sympathy to the members of his family: to
