WHEREAS, Involved in a number of local organizations, Mayor Young shared his time and talents with the Overton Golf Association, the Overton Cemetery Association, the Texas Association of Sports Officials, and the Circle Eight Square Dance Club, which he helped organize, and he was a former deacon at the First Baptist Church; and
