- 1 WHEREAS, The Stephen F. Austin State University men's
- 2 basketball team reached a new level of success during the 2008-2009
- 3 season by winning the Southland Conference Tournament and earning a
- 4 bid to the NCAA Tournament; and
- 5 WHEREAS, The Lumberjacks put together a conference record of
- 6 13 wins and just 3 losses to claim their second consecutive
- 7 Southland Conference regular season championship; entering the SLC
- 8 tournament as the number one seed, they bested Southeastern
- 9 Louisiana University and Texas A&M University--Corpus Christi to
- 10 earn a spot in the finals; and
- 11 WHEREAS, Facing off against The University of Texas at San
- 12 Antonio in that contest, SFA seized control in the first half and
