12 WHEREAS, A former director and president of the Hidalgo 13 County Bar Association, Judge Ramirez has also taken a leading role 14 in the State Bar of Texas, serving on the board of directors, on a committee to ensure the representation of the poor in civil 15 matters, and on a task force to ensure the continuation of court 16 operations throughout the state in the event of an emergency; in 17 addition, he has served on a committee charged by the Fifth 18 Administrative Judicial Region of Texas with setting the 19 20 qualifications for appointment as counsel in death penalty cases 21 and with evaluating the eligibility of attorneys for such an 22 appointment; and

23 WHEREAS, Deeply committed to public service, Judge Ramirez 24 has helped guide the Mental Health Association in Texas as a member

1 of its board, and he has held membership in the Texas Council on 2 Offenders with Mental Impairments; in addition, since 1982 he has 3 served as the overseer of the Hidalgo County Juvenile Probation 4 Department; in recognition of his longtime efforts to address 5 issues related to juvenile offenders, a newly constructed 6 preadjudication facility in Edinburg was dedicated as the Judge 7 Mario E. Ramirez, Jr., Juvenile Justice Center in March 2008; and

8 WHEREAS, Born in Roma, Judge Ramirez is a 1968 graduate of Rio 9 Grande City High School; he received his bachelor's degree from the 10 University of Notre Dame in 1972 and his law degree from St. Mary's 11 University in 1974; and

12 WHEREAS, For more than three decades, this distinguished 13 jurist has embodied the highest standards of his profession and 14 rendered immeasurable service to his community; now, therefore, be 15 it
