- 17 soldier who received the Bronze Star, the Purple Heart, three Army
- 18 Commendation Medals, two Army Good Conduct Medals, and the National
- 19 Defense Service Medal, among others; and

- 21 country, Joshua Ward upheld the highest ideals of the United States
- 22 armed forces, and his fellow citizens owe him a debt of gratitude
