5 WHEREAS, Born on August 29, 1952, to Samuel and Willie Pearl

6 Chambers Britt in Dallas, Cedric Britt graduated from Lincoln High

7 School and discovered his calling to the ministry at the age of 17;

8 he served as pastor of Koinonia Baptist Church in Indiana for four

9 years and came to Fort Worth in 1979 to preach at historic Mount

10 Gilead; his inspired work in leading the church made him one of the

11 most respected ministers in the area, and he was renowned for his

12 intellect and his masterful skill as an orator; and

WHEREAS, Dr. Britt earned his bachelor's degree at Bishop

14 College and graduated from Southwestern Baptist Theological

15 Seminary; he was the recipient of an honorary doctorate of divinity

16 and studied at Regent's Park College at the University of Oxford;

18 WHEREAS, This influential pastor involved himself locally

19 with numerous community and religious organizations, including the

20 Baptist Ministers Union, the Interdenominational Ministers

21 Alliance of Fort Worth, and the Citizens and Minority Business

22 Leaders of Tarrant County, and he served as president of the Fort

23 Worth chapter of People United to Save Humanity; at the regional and

24 national levels, Dr. Britt served as a member of the board for the

- 1 National Baptist Congress of Christian Workers and for Rotary
- 2 International, and he associated himself in various capacities with
- 3 the National Baptist Congress of Christian Education, the
- 4 Progressive National Baptist Convention, USA, and the Southern
- 5 Baptist Convention; for the past 13 years, he preached at the
- 6 National Baptist Convention of America, and he was life member of
- 7 the NAACP; and
- 8 WHEREAS, A dedicated family man, Dr. Britt enjoyed the love
- 9 and support of his wife, the former Joyce Hall, in all of his
- 10 endeavors; the couple shared 31 rewarding years of marriage and
- 11 became the parents of two children, Karen Britt and Cedric Deon
- 12 Britt, Jr., who preceded his father in death; and
- WHEREAS, The Reverend Cedric Britt dedicated his life to his
- 14 faith and his family, and he leaves behind a legacy that will
- 15 continue to inspire all those who were privileged to know him; now,
- 16 therefore, be it

- 18 Legislature hereby pay tribute to the memory of the Reverend Dr.
- 19 Cedric Deon Britt and extend sincere sympathy to the members of his
