- WHEREAS, Born on October 23, 1916, the former Sammie Lee
- 5 Harper grew up in Lodi in Marion County; she graduated from Central
- 6 High School in Jefferson, and shortly thereafter, she moved to the
- 7 Sherman area with her family; and
- 8 WHEREAS, In her early 20s, she married the love of her life,
- 9 Charlie Edward Sims, whom she had known since first grade; the
- 10 couple were blessed with two sons, Theophlous and William, and
- 11 enjoyed 55 years together, until Mr. Sims passed away in 1992; and
- WHEREAS, Mrs. Sims attended the Madam C. J. Walker School of
- 13 Cosmetology in Dallas and operated the Ever-Ready Beauty Salon in
- 14 Sherman after her graduation; determined to further her education,
- 15 she became one of the first African Americans to enroll at Austin
- 16 College in Sherman, and her example helped inspire future
- 17 generations of her family to devote themselves to their studies; in
- 18 1972, she and her husband relocated to Fort Worth, where their sons
- 19 lived, and the family founded a business, Sims Enterprises, Inc.,
- 20 with Mrs. Sims serving as secretary; and
- 21 WHEREAS, This esteemed Texan took great comfort in her faith;
- 22 during her youth, she attended Mount Moriah Baptist Church in Lodi,
- 23 and she was a very active member of the congregation at St. James
- 24 United Methodist Church in Sherman and Morningside United Methodist

- 1 Church in Fort Worth; she and her family later helped found Campus
- 2 Drive United Methodist Church, where Mrs. Sims served as lay
- 3 speaker for the congregation; in addition to her church activities,
- 4 she was a member of J. C. Boger Chapter No. 229 of the Order of the

- 6 WHEREAS, Known to many as "Aunt Sammie" or "Mama Sims,"
- 7 Sammie Lee Sims will be deeply missed, but the memory of her warmth,
