- 1 WHEREAS, The gospel music community and southeast Houston
- 2 have lost a beloved matriarch with the death of Shirley Joiner on
- 3 March 16, 2009; and
- WHEREAS, A gifted singer, songwriter, musician, and choir
- 5 master, Ms. Joiner demonstrated her great faith through her myriad
- 6 contributions to her church and to sacred music, and she gave
- 7 generously of her time and talents as a mentor to young people; in
- 8 1970, "Ms. Shirley" joined with Brenda Waters and Carl Preacher to
- 9 organize the Southeast Inspirational Choir, providing a musical
- 10 outlet for young people from a number of Houston churches; the three
- 11 friends also formed the trio B. C. & S. and recorded for the Savoy
- 12 label with both groups, and as the backing vocalists for Sarah
- 13 Jordan Powell; and
- 14 WHEREAS, The choir reached the Top 40 on Billboard magazine's
- 15 gospel chart with its album 15th Annual Praise and Rededication
- 16 Concert, retaining that status for 29 weeks; Ms. Joiner was an
- 17 exacting director who brought out the very best in singers, and she
- 18 earned their admiration through her warmth, humor, and kindness as
- 19 well; and
- WHEREAS, The mother of four, Ms. Joiner was deeply committed
- 21 to all the children of Houston and helped provide moral guidance and
- 22 encouragement through Southeast Inspirational Choir Ministries,
- 23 organized in 1977; she also served as the executive director of
- 24 SEICM's Preparing Holy Disciples, an annual program launched to

- 1 provide meaningful social and educational experiences as well as
- 2 crisis intervention and referral, training opportunities, and role
- 3 modeling instruction and counseling for parents and youth leaders;
- 4 and
- 5 WHEREAS, Ms. Joiner became minister of music at Outreach
- 6 Missionary Baptist Church in 1969 and produced three recordings for
- 7 its music ministry; when she retired from this position after
- 8 several decades, she continued to serve the church as youth leader,
- 9 Christian education facilitator, and discipleship class teacher,
- 10 and she remained an active member of the women and girls ministry;
- 11 and
- WHEREAS, For 30 years, Ms. Joiner served with Sister Theola
- 13 Booker, V. Michael McKay, and Gwen Pierre as a director of the Al
- 14 Edwards Juneteenth Choir; moreover, she conducted workshops and
- 15 performed around the country and was a charter member of the Houston
- 16 chapter of the Gospel Music Workshop of America; she helped develop
- 17 the musical talents of countless students as the proprietor of
- 18 A-All About Music, a business offering instruction in dance, music
- 19 theory, organ, voice, and improvisation; and
- WHEREAS, Shirley Joiner was a blessing in the lives of all who
- 21 knew her, and although she will be profoundly missed, the beauty of
- 22 her music and her ministry will forever remain an inspiration to
- 23 others; now, therefore, be it
- 24 RESOLVED, That the House of Representatives of the 81st Texas
- 25 Legislature hereby pay tribute to the memory of Shirley Joiner and
- 26 extend sincere sympathy to the members of her family, to her host of
- 27 friends, and to all who mourn the passing of this esteemed woman;
