- 6 around Houston; the initiative was started by a group of 10
- 7 volunteers who provided free medical care, computer literacy
- 8 classes, and legal consultations to their clients on weekends in a
- 9 small room in Southwest Houston; and
- 10 WHEREAS, From humble beginnings, this charitable
- 11 organization has grown to include 160 volunteers; 55 specialist
- 12 doctors operate out of four clinics throughout the Bayou City,
- 13 providing free outpatient medical care to individuals in need; to
- 14 date, more than 17,000 people have benefited from Shifa Foundation
- 15 services, valued at nearly \$3 million; and
- 16 WHEREAS, To better meet the needs of its patients, Shifa
- 17 Foundation has founded two centers for adult and child education
- 18 and has partnered with Masjid Teleem to operate a rehabilitation
- 19 center for ex-offenders; the organization also extends assistance
- 20 to those in need of family crisis intervention, senior citizen
- 21 support, and low income housing; in addition, the group works to
- 22 provide interim boarding and lodging to victims of family abuse;

- 24 WHEREAS, In 2007, the City of Houston awarded the

- 1 organization a grant for the construction of a new facility, and the
- 2 Kelsey-Seybold Clinic generously donated equipment and furnishings
- 3 for the clinic; and
- 4 WHEREAS, The Shifa Foundation and its dedicated volunteers
- 5 provide critical services to vulnerable members of our society, and
- 6 the Shifa Abu Bakr Clinic adds to the organization's ability to
- 7 fulfill its noble aims; now, therefore, be it

- 9 Legislature hereby honor the Houston Shifa Services Foundation on
